

**YAPP STUDIOS, INC. PURCHASER'S
AGREEMENT, RELEASE AND ACKNOWLEDGMENT OF RISK**

In consideration of the sale to us of the Roof 101 parts and Head (collectively referred to as "ROOF") by YAPP STUDIO'S, INC., their agents, owners, officers, contractors, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "YAPP"), I hereby agree to release and discharge YAPP on behalf of myself, my children, my parents, my heirs, assigns, personal representatives, and estate as follows:

1) I acknowledge that installing the ROOF overhead valve conversion cylinder head and all parts associated with it onto my engine will increase its performance and power and that all such speed, performance and racing equipment has known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply can not be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Higher revolutions per minute, greater engine torque, greater engine horsepower, greater cylinder compression, and greater stress on all moving and stationary parts will be encountered. It is possible that my engine could throw a connecting rod, crack a crankshaft, throw a fan blade, strip a timing gear, break a piston, compress or crack my bearings and make my engine useless. I understand that if a valve head breaks off, my piston, head and cylinder wall may be damaged. I understand that fuel and oil consumption might change. I can be jolted, jarred, bounced and shaken about and experience greater need for braking during rides in a ROOF powered vehicle of my choice. Accidents could happen or my engine could break down. I could loose control of my ROOF powered vehicle and crash resulting in damage to equipment, property or personal injury. I am aware of these possible threats to my safety including the possibility of accidental injury or death to myself and of others in the proximity of my engine and/or vehicle.

Furthermore, YAPP has a difficult job to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's intended purposes, modifications, fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2) I expressly agree and promise to accept and assume all of the risks existing in installation and use of my ROOF. My participation in this activity is purely voluntary, and I elect to participate in spite of the known and unknown risks.

3) I further agree to make any modification(s) to my vehicle which may be required by the increase in power or speed if any.

4) I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless YAPP from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of the ROOF, YAPP's equipment or facilities, including any such claims which allege negligent acts or omissions of YAPP including but not limited to claims by me or any third party.

5) Should YAPP or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.

6) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume - and bear the costs of - all risks that may be created, directly or indirectly, by any such condition.

7) In the event that I file a lawsuit against YAPP, I agree to do so solely in the State of Ohio, and I further agree that the substantive law of that great state shall apply in that action without regard to the conflict of law rules of that state.

Plain English Statement

By signing this document, I acknowledge that if anyone is hurt or property is damaged while using my ROOF, I may be found by a court of law to have waived my right to maintain a lawsuit against YAPP on the basis of any claim from which I have released them herein.
