**Health Department Vaccine  
Update**

Vaccine clinics will start on Monday, January 11 for people that are at least 75 years old, are a Richmond County resident, and have scheduled an appointment by calling 910-417-3030. Be prepared to leave a message with your name, date of birth, email address and a phone number. A representative will call you back within 72 hours to schedule your appointment.

The Covid vaccine requires two doses. The second dose will be given 28 days after the first dose. Your second appointment will be scheduled when you get your first dose. All residents of Richmond County will receive the Moderna vaccine.

Please be prepared to wait 30 minutes after you have received the vaccine to watch for side-effects. You will be monitored by hospital personnel.

Additional vaccination phases for those under 75 and other essential workers will be announced and dictated by the State.
