## **JOB OVERVIEW**

The role of the Discovery Kids Mother's Day Out (MDO) Substitute Teacher is to provide a safe and fun learning environment for our MDO Ministry. Our ministry includes children ages 6 months-5 years.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- Prepare and execute age appropriate lesson plans in a MDO setting.
- Maintain a positive and fun learning environment.
- Work closely with a teaching partner.
- Help students follow their normal routine in a classroom setting.

## **OTHER SKILLS AND ABILITIES**

- The successful candidate must be a Fully Devoted Christ-follower, called and dedicated to the ministry of children and parents and fully support the ministry of Houston Northwest Church and its leadership team. This individual's commitment to Christ will be evidenced in their personal life, family relationships, and ministry. Incumbents daily walk with God will be an example to the children, parents and others with which (s)he interacts.
- The ideal candidate will have the ability to work independently as well as in team environments.

## **PHYSICAL DEMANDS**
