- e. Applicants agree that their students will receive instruction in the Christian Faith and understand that the school will endeavor to be guided by a Christian Worldview in all of its programs and activities.
- f. The school has policies designed to meet a reasonable standard of care for students who become ill or have an emergency situation as school. Parents are required to sign a medical release from each year allowing emergency medical care to be obtained in the case parents cannot be reached. Parents understand that school is no an insurer of student health.

A non-refundable \$125 enrollment fee is due upon enrollment.
