President's Message

Fairfax County's \$3 Billion Budget To Be Discussed at March Meeting

A \$3 billion budget has been proposed for Fairfax County for the fiscal year beginning July 1, 2005. Of that figure, \$1.56 billion is earmarked for the school system. A 10¢ reduction, from \$1.13 to \$1.03, in the tax rate is being proposed to partially offset the more than 23% increase in property values over the past year. You know the old joke...the good news is your house is worth more...the bad news is it's going to cost you!

I will be attending a three-hour budget presentation organized by Supervisor Kauffman prior to the Rose Hill Civic Association's March 22, 2005, meeting, 7pm at John Marshall Library. A detailed overview of the proposed budget will be available at the meeting. We will collect questions and forward them to the County for answers.

The Association also will discuss what, if any, action it wishes to take concerning the Transport Fee to take effect on April 1. Members of the Association heard a presentation on the fee last month. The answers to questions raised at that meeting are on page 6. The fee will be charged for transport to a medical facility or hospital.

In addition to a tax increase triggered by the increased value of our homes, there are numerous fees that are being proposed, including one for sewer service. We will try to provide information on all of them at the March 22 meeting.

If you would like to learn more about how your tax dollars are spent, please plan to attend our March 22 meeting. If you have specific questions, we will pass them on to Supervisor Kauffman, School Board member Brad Center, or the appropriate county agency. For those with internet access who would like information on the budget in advance of the meeting, go to fairfaxcounty.gov/dmb/.

thought we would educate everyone about the rules governing the keeping of animals in a residential neighborhood. Section 108-5-2 of the Fairfax County Code prohibits "owning, keeping, or harboring an animal or animals which frequently howl, bark, meow, squawk or make such noises as is plainly audible across property boundaries or through partitions common to two (2) or more persons within a building." Residents are reminded that criminal sanctions are a possibility should the property owner not control the animal. Dog owners also are reminded of Fairfax County's leash and mandatory cleanup of waste laws. As a dog owner, I am careful to respect my neighbors' property and the community. I trust all the other dog owners will do the same. If not, the consequences can be embarrassing.

Section III Update

The County engineer reports that the developers of Section III have *not* submitted the expanded soils information necessary for evaluation to determine if a site plan can be approved. The County estimates it will be several months before the information obtained in the testing that occurred in December and January is refined and submitted for review. RHCA will be advised when the information is available and will schedule a presentation by the County engineers for all those in the community who are interested. Again, RHCA's interest is focused on protecting existing houses and maintenance of an adequate buffer to do so. To review, the zoning for 45 lots has been approved. However, the exact number (it can go down but not up) is dependant on the final engineering and soils report. Because of the presence of marine clay, RHCA has continually focused on safety of both the new and existing houses. Section III is bound by Rose Hill Drive and Cottonwood Drive on the east, Carriage Drive on the south, and May Boulevard and Silo Road on the north.

All information will be confidential and will be passed on to the authorities in the name of the Association, not individual members.

Privacy

Internet search engine, Google, has implemented a new feature wherein you can type someone's telephone number into the search bar and hit enter and then you will be given a map to their house.

If a child, or anyone else for that matter, gives out his/her phone number, someone can now actually look it up to find out where he/she lives. I tested it by typing my telephone number into the google.com search line. My phone number came up, and when I clicked on the MapQuest link, it actually mapped out where I live. But you can have your phone number removed or blocked.

In order to test whether your phone number is mapped, go to <http://www.google.com>. Type your phone number in the search bar (i.e., 555.555.1212) and hit enter. If you want to block Google from divulging your private information, simply click on the number and it will ask you if you'd like to remove it. Removal takes 48 hours. If you are unlisted in the phone book, you might not be in there, but it's a good idea just to check.

Internet Scam

This was a scam, not spam! — Carl Sell

An Alexandria area man was defrauded of \$6,300. In December of 2004, a 41-year-old man met a woman from Nigeria through an online dating service. He sent her \$500 by Western Union in early January of 2005 when she said she needed money due to an illness. The woman then sent him a United States Postal Money Order for \$6,300 and asked him to cash it at his bank before sending the money to three different people in Lagos, Nigeria. The victim followed her instructions and sent the money to Nigeria. The man then received notice from his bank that the money order was counterfeit and his bank account was debited the full amount. This is the first known case of United States Postal Money Order fraud in Fairfax County.

Update

After the victim cashed the first money order, the Nigerian internet acquaintance sent him nine more and asked him to wire the funds to Nigeria. However, the victim became suspicious and was also informed that the original money order was counterfeit.

This is not the first case of money order fraud in Fairfax County.

The following should remind all of us to keep our eyes on the children as they walk to Rose Hill School!

A man exposed himself to three elementary school students as they walked to school. On March 7, around 8:30am, three girls, 10-, 11-, and 12-years-old, were walking to White Oaks Elementary School when they passed a man in his vehicle. The vehicle was stopped at the intersection of Cordwood Court and Shiplett Boulevard. The man called to the students and then exposed himself to the 12-year-old girl. The students continued on to school where they reported the incident to school officials, who then summoned police. Police are investigating a suspicious incident that occurred on January 28, where a man fitting the same description as the March 7 incident, called to students walking to White Oaks Elementary School.

In both incidents the man was described as white with short brown or dirty blond hair, and driving a silver SUV. In the January 28 incident, the man was wearing a brown sweater and in the March 7 incident, he was wearing blue jeans.

Answers to Questions Regarding Transport Billing Raised at the February RHCA Meeting

How did the County determined what fees to charge for EMS Transport Billing?

Rate structures throughout the state and country were reviewed. The rate schedule below is recommended based on a consideration of representative rates and in conjunction with the Panel's recommendation to ensure maximum cost recovery while minimizing out-of-pocket costs for residents. The structure allows for appropriate recovery based on the level of care required and is consistent with ambulance transport billing practices.

Type of Service	Recommended Rate
Basic Life Support (BLS) Transport	\$300.00
Advanced Life Support (ALS) Level 1 Transport	\$400.00
Advanced Life Support (ALS) Level 2 Transport*	\$550.00
Mileage (per loaded mile)**	\$7.50

*ALS-2 transports account for less than 4% of all ALS transports.

**Mileage from patient pick-up to hospital.

Approximately, how much will the County generate on EMS Billing Funds?

Based on this fee schedule, staff conservatively estimates that the potential net revenue stream will approximate \$310,000 in the first year of implementation, since no revenues are expected to be received before April 2005. Once the program is fully operational, annual net revenues are estimated to approach \$5 to \$7 million.

What is the fee for EMS Transport for the City of Alexandria and Arlington County?

How much does the Fairfax Hospital Helicopter and the Fairfax County Police charge for Medical evacuation transport?

Currently, there is no charge for the Fairfax County Police transport. Inova does charge for transports but further research needs to be done to find out what the charges are.

In the event I am transported to the Springfield Healthplex via ambulance and require further transportation to a specialized medical facility such as Inova Fairfax or Inova Alexandria, will I be charged for twice, or once?

Fairfax County Fire and Rescue only provides emergency transports. If the patient requires a non-emergency transport to another facility that will be handled by a private ambulance service and a second bill may result.
