## President's Message

### **Proposed Church on May Boulevard, Tax Rate to be Discussed by RHCA**

Representatives of the Agape Embassy Ministries Church will be at the March 24 meeting of the Rose Hill Civic Association to present plans for a church and other facilities at the current Kindercare site on May Boulevard. Long-time residents will recall that this was the site of the Meadowview Swim Club and then Heritage Academy.

After the presentation on the church proposal, we will discuss 2009 real estate assessment and the proposed tax rate and decide what, if any, advice we wish to pass on to the Board of Supervisors. The Board has advertised a tax rate of \$1.05 per \$100 for 2009.

The meeting will be held in the community room of the John Marshall Library. It will begin at 7pm with the church presentation, followed by questions and answers. We have set aside an hour for this exchange. The tax discussion will begin at approximately 8pm. We must vacate the Library by 9pm.

David Hunter from the firm of Burgess and Niple will present the church plan. Pastor Joseph Mills will be on hand to answer questions concerning the church

and its proposed operation. The church currently meets in Kingstowne in the office space near WalMart.

Agape Embassy Ministries Church will need a Special Permit from the Board of Zoning Appeals in order to move forward with its plans. Churches are permitted in residentially zoned areas by Special Permit only. The four-acre property is zoned R-3, the same as the rest of Rose Hill. The use must be in conformance with the comprehensive plan and meet provisions of the zoning ordinance.

Questions concerning traffic, intensity of use, and buffering are issues that have been raised by nearby residents. On behalf of RHCA, I have raised the issue of preservation of the silos that currently exist on the property. They are the last reminder of the original Rose Hill Farm. In fact, they are the last remaining structures that depict the farming culture in all of Franconia.

If you live near the proposed church, please try to attend this important meeting. At some point, RHCA will be asked to take a position on the proposal and we need to hear every member's voice. We will endeavor to keep everyone informed as we go ahead through *The Rambler* and myRoseHill.com.

### **Assessments, Tax Rate Discussion**

Since the value of homes keeps going down, so does County revenue. Real estate represents 63.8 percent of County revenue. Assessments are down an average of 14 percent this year. That, along with decreases in

other revenue, has left the County with a \$631 million deficit. The County Executive has proposed a budget that would close that gap by increasing the tax rate, cutting spending, and limiting the schools to the same amount of revenue received last year. Of the \$631 million deficit, the County Executive proposes to close the gap by increasing tax revenue by \$267.1 million, making cuts worth \$106.4 million from the County side the budget, \$19.1 million by eliminating pay for performance and merit pay, \$12, 6 million in revenue enhancements, and \$8.4 million in other savings. To meet the \$631 million, the schools would have to cut another \$136 million. After receiving the County Executive's proposal, the Board of Supervisors voted to advertise a tax rate of \$1.05 per \$100 of assessed value. Last year's tax rate was 92 cents of assessed value. Starting March 31, the Board will conduct a series of public hearings before determining the final budget and tax rate. As an Association, we have the opportunity to advise the Board as to our concerns about the proposed budget. There are several proposed cuts that will directly affect Rose Hill such as cuts in police and fire activities, hours at the library, and support for Neighborhood Watch and zoning enforcement. Information on all of these will be available at the March 24 meeting. Supervisor McKay has already said that he is concerned about cuts in public safety. We need to take a look at other items proposed to be cut and give him our thoughts. Also, we need to decide whether or not to support the tax rate which would result in an increase over what homeowners paid last year. Your thoughts are important and this is your chance to make them known. Plan to attend the March 24 meeting.

#### **Crime on The Rise**

In recent weeks, at least three cases of stolen license plates have been reported in Rose Hill. Additionally, there have been at least three cases of items stolen from vehicles, including a stereo, a purse, and a GPS device. Reports of stolen items from vehicles also are on the rise in nearby communities. Residents are reminded to lock their cars, even if they are in the driveway in broad daylight, just like you do at night. Makes sure the license plates on your car are as secure as you can make them so thieves will have a hard time removing them. Be particularly on guard as soon as you acquire new plates that are good for two years. They are a favorite target for obvious reasons. As you know, we are in the process of organizing a block-by-block Neighborhood Watch program in Rose Hill. The response has been good, but we still have room for more help. Call if you are willing to watch out for the

The Franconia Museum is sponsoring a Civil War 'Both Sides' Tour on Saturday, April 25. 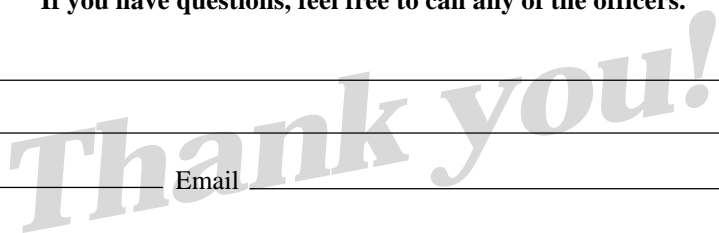

## The Fairfax County Public Schools Proposed Bell Schedule: Results From The Online Survey

In an ongoing effort to provide the best and most developmentally appropriate education for all students, the Fairfax County School Board has been researching several options to adjust the current bell schedule. Through the Transportation Task Force, community dialogue meetings, and an online survey, the School Board has been gathering community input to assist it in its decision-making process. Most recently, an online survey was posted from February 9, 2009, to February 28, 2009, so that the Fairfax County Public Schools (FCPS) community, including students, parents, staff, and community/business members, had the opportunity to provide their opinions regarding the proposed bell schedule.

The purpose of the survey was to provide the opportunity for all FCPS constituents to give feedback regarding the proposed bell schedule. Rather than selecting a representative sample so that results could

provide a snapshot of information to be used with a variety of other sources as the School Board considers making adjustments to the current bell schedule. The survey was accessible via the FCPS website for parents, staff, and community/business members and via Blackboard for FCPS students in grades 6 through 12. Respondents were able to access the survey from any computer with Internet capability. Though respondents were expected to respond to the survey just once, there were no electronic limitations put in place to limit access to the survey. After data were gathered, a review of computer IP addresses was conducted to determine if multiple responses from the same computer were included. Results indicate a small percentage of responses can be traced to the same IP addresses, though this percentage would not have a significant impact on the survey results.

A total of 94,129 respondents participated in the survey, including 29,286 students, 49,583 parents (including 621 respondents in Spanish and 368 respondents in Korean), 12,925 FCPS staff, and 2,335 community/business members. Survey participants were asked a series of questions to determine whether or not they supported the proposed bell schedule, how the proposed bell schedule would impact their lives, and their preferred timeline for implementation. Across all respondent groups, approximately 63 to 78 percent of respondents do not support the proposed bell schedule. A summary of results is presented in Table 1.

be generalized, the survey was intended to be available to the full community. In addition, it was meant to gather specific information about a variety of potential impacts ranging from staff commute time to child care needs and family time. The survey
