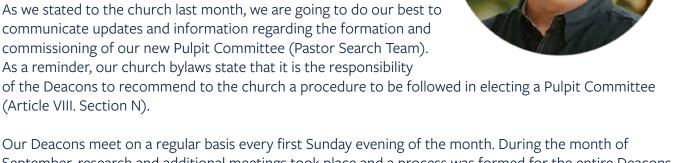
From Our Executive Pastor

As we stated to the church last month, we are going to do our best to communicate updates and information regarding the formation and commissioning of our new Pulpit Committee (Pastor Search Team). As a reminder, our church bylaws state that it is the responsibility

of the Deacons to recommend to the church a procedure to be followed in electing a Pulpit Committee (Article VIII. Section N).



September, research and additional meetings took place and a process was formed for the entire Deacons to review and discuss at the regular monthly meeting on October 3. The Deacons unanimously voted on a final recommendation for the process of forming a Pulpit Committee to be presented to the church on Sunday, November 14, at our quarterly Gather Grow Serve event.

A special thanks goes to our current Deacon leadership: Jason Grace (Chair) and Keith Galloway (Vice-Chair) as well as Chris Potter (Chair of Policies & Procedures Committee) and Robert Scott (former Deacon Chair). Their tireless work and effort led the way with our entire Deacon body in creating this recommendation. We also want to thank all 45 of our Deacons for their leadership of prayer, love, support, and unity during this process. It is further evidence of the strong stability of Immanuel and the guidance of the Lord over our church!

Lives continue to be changed with the Gospel. Baptism waters are moving each week. More and more people are connecting to IBC and joining in our vision and mission. Invite your friends, co-workers, neighbors, and family to visit us. There's no better time to spread the love of Jesus than right now!

Pastor Search Process

The following motion was unanimously approved by the Deacons of Immanuel Baptist Church on October 3, 2021.

Proposed Motion - Pulpit Committee

The Deacons of Immanuel Baptist Church recommend that the church elect a Pulpit Committee consisting of seven (7) voting members of the church and one (1) non-voting staff member to be selected through the following procedure:

- 1. Church members will be able to submit nominations for the committee once this motion is approved by the church at its regularly scheduled business meeting on November 14, 2021.
 - a. Nominees must be an active member of Immanuel for three (3) years.
 - b. The Deacon Election Committee will accept these nominations and ensure they are valid and that nominees are willing to serve on the Pulpit Committee.
 - c. Nominations will close December 31, 2021.
- 2. Voting will take place in January 2022 on a date to be determined between the Deacons and the Pastoral Staff.
 - a. The Armstrong Mill campus members will vote for one (1) committee member from the five (5) men and five (5) women receiving the largest number of nominations that are willing to serve on the Pulpit Committee. The person receiving the most number of votes will be selected.
 - b. The Tates Creek campus members will vote for six (6) committee members from the ten (10) men and ten (10) women receiving the largest number of nominations that are willing to serve on the Pulpit Committee. The six (6) people receiving the most number of votes will be selected.
 - c. The church staff will select a representative to the committee through a process determined by the staff. This representative will participate on the Pulpit Committee, but will not vote to select the lead pastor.
 - d. At least two (2) men and two (2) women must be selected as voting members of the Pulpit Committee.
 - e. Only one (1) member of an extended family may be elected to the Pulpit Committee.
 - f. The Deacon Election Committee will oversee the election.
- 3. The Pulpit Committee will be announced and commissioned after the election with a planned date of the Summit in the Summit on February 6, 2022.

FROM OUR FINANCE COMMITTEE

The Finance Committee is pleased to present the 2022 budget. The Finance Committee, along with our ministers and staff, under the leadership of our Executive Pastor, Bradley Thomas, have worked diligently during 2021 to ensure Immanuel maintains financial stability, while forming the foundation for future growth. Our fully audited financial records continue to speak to the financial integrity of the church's budgeting process.

2021 has been a challenging year with the continuation of the COVID crisis and the resignation of our Lead Pastor in September. However, there is much to be thankful for and God is doing GREAT things in our church! In January of 2021, we paid off the church debt, removed any debt retirement and interest from our budget, and moved part of those funds to facilities and personnel. Our mission remains and we will not slow down or retreat.

In 2021, we continue to have one church with two locations, and God continues to bless our efforts in leading people to Jesus and equipping disciples. Now we are in preparation for adding a third campus in Georgetown starting February 6, 2022. This new campus will be under the leadership of the Georgetown Teaching Pastor, Brandt Lyon, and we are already seeing the impact in the Georgetown community. In addition, we recently shared the hiring of our new Armstrong Mill Teaching Pastor, Travis Fox, who will start December 5, 2021. We believe this is an important and necessary step in capitalizing on the neighborhood location of our Armstrong Mill campus!

We have some truly great opportunities and challenges before us – but we must always walk in faith knowing that God will provide. Your generosity makes it possible to continue changing lives and impacting our region with the Gospel! Thank you to those who remain faithful in the mission God has for us here at Immanuel. Your willingness to step out "on mission" and serve has been phenomenal.

Below are a few helpful highlights. In the 2022 budget, tithes and offerings will make up 86.97% of our total operating revenue. Supporting/Misc. Revenue and Departmental fees amount to 13.03% of the total budget, such as our sharing of facilities with Lexington Christian Academy, our recreation outreach facility, memorial gifts, and endowment account.

As a reminder, our budget is based on a 50-week year rather than 52. We have two special Sunday offerings, Joash and Christmas for Christ. Those are not included in the annual budget. The Joash Offering is used specifically for maintenance and improvements to Immanuel's campus, and the Christmas for Christ Offering is used specifically for reaching people locally, regionally, and globally.

Our expenses are divided into three primary areas:

- 1. Local, state, and international missions, including our Southern Baptist Convention Cooperative Program (National and International Missions) and Central Kentucky Baptist Association (Local Missions).
- 2. Direct ministry through ministry staffing.
- 3. Building operation and maintenance.

FROM OUR FINANCE COMMITTEE

As a church we will continue to be generous toward our mission partners. We cooperate in giving and serving with Southern Baptist missions and the Central Kentucky Network Baptist Association, along with countless other partnerships with which we prayerfully engage. Cooperative giving, to Southern Baptist missions, is staying the same at 9.25% of budgeted tithes and our support of the Central Kentucky Network Baptist Association will remain at 1% of tithes. The membership of Immanuel has a strong legacy of commitment to local, state, and foreign missions. (We were recently recognized as the single largest contributing Baptist church in Kentucky.) We believe the 2022 budget reflects this continued strong commitment as we've increased our commitment to missions. God will always bless a GIVING church!

Please take the time to review this budget. On Sunday, November 21, from 8:00 -9:00 am in Sisk Chapel, we will have an open question and answer time concerning the proposed 2022 budget with our Finance Team. Then on that same Sunday, November 21, at the end of our 11:15 am service at our Tates Creek campus, the formal vote will take place as a congregation to confirm this budget and our commitment to give generously.

It is our desire to be good stewards of the resources God makes available to us as we continue the work of Immanuel. Feel free to ask questions. We ask you to keep our pastors, staff, and volunteer leadership committees in prayer as we do the work God has set before us. Thank you for your partnership in leading people to Jesus and equipping disciples in their faith!

FINANCE COMMITTEE RECOMMENDATIONS

The Finance Committee makes the following recommendations:

- That the 2022 Proposed Budget for Immanuel Baptist Church (Tates Creek, Armstrong Mill and Georgetown campuses) be adopted for approval.
- That every family of Immanuel considers participating in the Global Hunger Program. Proceeds
 from the program go to the Global Hunger Relief Fund. The church will have a special emphasis
 drive in correlation with Global Hunger Sunday.
- That in order to be consistent with the purpose of the unified budget, designation of gifts be
 discouraged (except for I Love My Church gifts, special mission offerings, and our annual Joash
 Chest and Christmas for Christ offerings), and if designated, such gifts be over and above the
 giver's regular tithes.
- Mission spending increase from \$1,048,536 to \$1,063,901.
