### PROGRAMS AND REGISTRATION

### PROGRAMS:

Newington Courthouse Preschool offers half-day programs for each of the following:

Program	Requirement	Hours	Days
3-Year-Olds	3 Years by	9:00-12:00	Tues. & Thurs.
	September 30		
4-Year-Olds	4 Years by September 30	9:00-12:00	Mon., Wed. & Fri.

### **REGISTRATION:**

Early registration will be offered in February to current students and children who attend Newington Baptist Church. Open registration will begin in March. All applications will be taken on first-come, first-served basis.

Receipt of the contract along with the registration fees will automatically reserve a place in school. A parent or guardian will be notified immediately if a class is closed.

### **REGISTRATION FEES**

3-Year-Olds \$120

4-Year-Olds \$150

Only \$40 of the Registration fee will be refunded if student withdraws before the first day of school. No refunds will be given after the first day of school.

### ADMISSION POLICY:

The Newington Courthouse Preschool admits any child without regard to race, religion, or ethnic background.

### **DISCIPLINE POLICY:**

Our discipline procedures will consist of the following strategies:

- 1. Encouraging children to use their words when having a disagreement with another child. Facilitating children in their attempts to settle their own disputes.
- 2. Redirecting behavior when this seems potentially effective.
- 3. Separating a child from the group (Time Out) one minute away for each year of age.
- 4. Making parents aware of disciplinary concerns.

Disruptive behavior distracts from the full benefit of the preschool program and will result in consequences. The following behaviors are considered disruptive:

- \* Requires constant attention from staff
- \*Inflicts physical or emotional harm on other children
- \*Disrepects people and/or materials provided in the program
- \*Consistently disobeys the rules of the classroom
- \*Uses verbal or physical activity that diverts attention away from the group of children
- \*Serious disruptive behavior will be addressed in an incident report
- \*If the child's beahvior continues to be inappropriate, consistently disruptive, and/or dangerous, it may be necessary for the child to be sent home for a period of time to be determined by the teacher and Preschool Director, or removed from the preschool program altogether.

### **TUITION:**

The yearly tuition is divided into nine equal monthly payments for your convenience. Tuition is due on the first class day of each month and is non-refundable. After the 10th day of the month a 10% late fee will be applied for each month tuition is late. Checks should be made payable to Newington Courthouse Preschool.

The tuition rate for this school year is as follows:

Program	Monthly Payment	Dates
3-Year-Olds	\$120	Sept. 1-May 1
4-Year-Olds	\$145	Sept. 1-May 1

The first Child will pay full tuition price, each additional sibling will receive a 10% discount.

FOR EXTENUATING CIRCUMSTANCES PLEASE CONTACT THE DIRECTOR.

### WITHDRAWAL:

This is an annual contract. Release from this contract will be given in case of relocation; however, a 30-day notice is required along with one month's tuition. If release from this contract is requested for any other reason, one-half of the remaining tuition is required. If requested before school begins, tuition payments will not be required. Newington Courthouse Preschool will not refund the tuition or any part thereof in the event of withdrawal, dismissal, or absence of the student during the course of the school year. In the event of such, the fees agreed to herein shall become at once due and payable. If the Preschool Committee determines that a child should be released based on our Discipline Policy, no further tuition will be due.

### DAILY EVENTS

### SNACKS:

This is a time when your child will learn to give thanks to God. The three- and four-year-olds are provided with a snack each morning.

All other food, candy or chewing gum should be left at home unless special arrangements have been made with the teacher.

### CLOTHING:

Children should wear comfortable clothing suitable to weather conditions. Shoes should be suitable for playground and gymnasium (preferably athletic shoes - no hard or black soled shoes). Please label all removable items with your child's first and last name (i.e. jackets, sweaters, hats). Please have a complete change of clothes in their backpack.

### PERSONAL ITEMS:

Please leave toys and other distractions at home to ensure an educationally focused classroom. You will be notified about special "Show and Tell" days.

### TRANSPORTATION:

Parents will provide transportation to and from school. Please notify the teacher in writing if someone other than the parent or guardian is picking up the child.

Upon arrival, please pull under the portico at the back of the preschool. A teacher will help your child out of the vehicle and into the building.

At dismissal time, a teacher will bring your child to the vehicle under the portico. Parents are responsible for securing their child in their vehicle. This will eliminate confusion inside. Please refrain from coming inside to pick up your child. If you need to pick your child up early due to an appointment, etc., please send a note with your child that morning. The teacher will have your child ready so that an unexpected arrival will not interrupt class time.

### LATE PICKUP FEE:

There will be a \$5 late fee for every 5 minutes a parent or guardian is delayed in picking up their child. Example: \$5 - 5 minutes; \$10 - 10 minutes, etc.

### **INCLEMENT WEATHER:**

In case of inclement weather, we generally follow the public school closings. Watch for Gloucester County Public Schools announcements on the local news stations. Those closings are announced on WXGM (99.1) and Facebook.

We will always be closed the first day if the public schools close. Sometimes we may return sooner. You will receive an email or check Facebook if this should happen.

### SPECIAL EVENTS

Parents will be given the opportunity to attend at least one special activity, so that they may share with their children in these growing and learning opportunities.

### GET ACQUAINTED DAY:

Parents and students are invited to the school for a short visit. A letter will be mailed during the summer confirming the date and time of your visit. You will be asked to bring the first month's tuition and a copy of the following:

- 1) child's immunization record
- 2) child's birth certificate
- 3) child's social security card

Newington Courthouse Preschool must receive these records, due to state licensure, before student can begin school in September.

### **BIRTHDAY:**

Each child's birthday is celebrated. Parents may make arrangements with the teacher to bring in refreshments to share with the class.

If your child's birthday falls outside of the school year, please see the director for more details.

Presents and/or party favors are not appropriate in a school setting.

### FIELD TRIPS:

Field trips may be planned to enhance a unit of study.

### **SHOW AND TELL:**

Children (four-years-old) will be invited to bring items for "Show and Tell." These items are usually related to the topic of study.

Please consult the teacher if your child would like to share other items of interest.

### GUEST READER:

Each month a member of Newington Baptist Church will share a Bible story with the children.

### **CONFERENCES:**

Conferences will be held three times a school year (November, February and May). Please plan to attend to discuss your child's progress. These conferences are more constructive when children are not present. Teachers are available for additional conferences upon request.

### **SPRING PROGRAM:**

There will be a Spring Program and picnic during the last month of school. Details concerning these events will be provided at a later date. Come and enjoy the fun.

### **CLASS PICTURES:**

Class pictures (individual, portrait type) will be taken in February.

### HOLIDAY CELEBRATIONS

### HARVEST

Our celebration will include God's natural world, seasonal changes, fall colors, apples, harvest and pumpkins.

### **THANKSGIVING**

During the Thanksgiving season, we will teach the goodness of God and His blessings. The children will learn about thankfulness, sharing, Native Americans, pilgrims and the first Thanksgiving.

### **CHRISTMAS**

Our main emphasis during the Christmas season will be the birth of our Lord and Savior, Jesus Christ. Other activities may include tree decorating, caroling and gift making.

### VALENTINE'S DAY

We will focus on our love for God and for each other. The children will participate in making and sharing valentines.

### EASTER

During the Easter season, we will celebrate Christ's resurrection.

### HEALTH

Please be sure that your child has regular visits to a doctor. Do not send a sick child to school. If a deep chest cough, severe cold symptoms, or open sores are present, please keep your child at home. Before your child returns to school, he/she should be free of fever, vomiting or diarrhea for a least twenty-four hours.

If your child becomes ill during a class session, a parent or guardian will be notified in order to make arrangements for an early dismissal, per director's discretion. Emergency phone numbers (work, home and other contacts) must be kept current with the child's teacher.

All children must be potty trained before enrollment in our preschool programs.

# The Commonwealth of Virginia and Department of Social Services requires that we post the following information:

Newington Courthouse Preschool is a half-day preschool program registered through the Commonwealth of Virginia, Department of Social Services under Religious Exemption status. Certification renewal is on a yearly basis.

Newington Courthouse Preschool at Newington Baptist Church, 6169 Main Street, Gloucester, Virginia is in the preschool wing which consists of three rooms on the right parking lot side measuring 80'x20' with two separate restrooms. An additional restroom available across the hallway in the toddler area. The fenced playgroound area is 78'x31'.

Student-teacher ratio will not exceed 10-1 in four-year-olds & 8-1 in three-year-olds classrooms.

No full meals are offered to students since this is a half-day program. A mid-morning snack is provided for preschoolers.

Staff health requirements provide that members must be certified annually by a practicing physician that they are free from any disability, which would prevent them from caring for children.

Newington Baptist is covered by liability insurance which provides coverage in the event that someone brings suit against the church for personal or bodily harm suffered during the operation of Newington Courthouse Preschool as a result of Negligence.

### Newington Courthouse Preschool Teacher Qualifications

Teacher qualifications include a high school diploma, at least twenty-one (21) years of age, displays Christ-like characteristics and love of young children necessary to be successful in teaching them. Staff hired after January 1, 1994 must have at least one (1) year of twenty-four (24) semester hours credit in subjects related to the care and education of preschool children and/or pragmatic experience in this area.

These procedures must be implemented:

- Hand washing by staff and children before eating and after toileting
- 2. Appropriate supervision of all children in care, including daily intake and dismissal procedures to ensure safety of children.
- 3. A daily simple health screening and exclusion of sick children by a person trained to perform such screenings
- 4. Ensuring that all children in the center are in compliance with Code of Virginia, the provisions of §32.1-46 regarding the immunization of children against certain diseases.
- 5. Ensuring that all areas of the premises accessible to children are free of obvious injury hazards, including providing and maintaining sand or other cushioning material under playground equipment.
- 6. Ensuring that all staff are able to recognize the signs of child abuse and neglect.
- 7. Ensuring that all incidents involving serious physical injury to or death of children attending the child day center are reported to the Commissioner. Reports of serious physical injuries, which shall include any physical injuries that require an emergency referral to an offsite health care professional or treatment in a hospital, shall be submitted annually. Reports of deaths shall be submitted no later than one business day after the dealth occurred.
