
THE LORD'S WORK IN US

GRANT & ALYSSA'S STORY

The primary goal of First to the Lord is for us all to take a personal discipleship journey in generosity. Like many, Grant and Alyssa Alderman's journey didn't start to feel personal until they had gotten a few months into it.

"My first reaction when we started the First to the Lord series was, 'Didn't we just finish building our home? Is this really what the church is called to?' says Alyssa. "We had felt stretched and called to help with the building, but we weren't so sure about this next step."

Six months after making a First to the Lord commitment, they started searching for a house, and that's when the journey got personal. "Looking for a house felt hopeless. The budget we had set didn't seem



like enough and I felt like something had to give. Honestly, in the back of my head I was thinking, 'We can adjust our giving, give less, and get a better house,'" says Grant. "But First to the Lord is not second to the Lord or leftovers to the Lord, so we had to settle in our hearts that we're going to be OK with what we can afford after giving. Otherwise it's not first to the Lord."

They did end up finding a home, and with it came confidence that it wasn't just their own plan. "First to the Lord shifts where the power is and who's in control. If I was in control, I was going to give less, and it would've been my plan and my house. But if we continue to give, it puts God in control and now it's his plan and his house," says Grant.

They have also gotten to experience First to the Lord from a second perspective. Alyssa works with Young Life Africa/Middle East to raise up future leaders in an under-discipled part of the world. "I'm a bridge connecting the global body of Christ with the mission to reach teenagers in Africa. But my job can feel more like an island, day-in-day out, like I'm alone. Does anyone see what I'm doing?" she explains.

First to the Lord has allowed Fellowship Denver to partner with her ministry (see next page), and that brings her more than financial help. It also puts wind in her sails. "It's an encouragement to me to know that I can share this ministry with people locally." This is what the Lord promised us when we started. "For the ministry of this service is not only supplying the needs of the saints, but is also overflowing in many thanksgivings to God" (2 Cor. 9:12).

CARES Act Provisions

As you plan for end-of-year giving, make sure you're up to speed on charitable giving benefits provided for in the CARES Act:

Normally, deductions for charitable contributions are limited to 60% of Adjusted Gross Income (AGI). For 2020 only, individuals may deduct up to 100% of their AGI. This presents an opportunity for those planning major cash gifts to greatly reduce their income taxes in 2020.

Unfortunately, this expanded limit does not apply to gifts to donor advised funds. It also applies to cash gifts only. Gifts of appreciated securities are still subject to their normal limit of 30% AGI.
