All prices are based on current tariffs, rates and foreign currency exchange rates subject to change herein without prior notice. Original price is guaranteed only upon payment in full.

TRIP CANCELLATION / INTERRUPTION INSURANCE

If traveller joins tour while in progress or departs from tour before tour is completed, traveller is responsible for any additional individual expense (airfare, hotels, transportation, etc.). There will be no refund for any unused portion of the tour. Any required medical expense is also the responsibility of the traveller. **TRIP CANCELLATION / INTERRUPTION INSURANCE IS STRONGLY RECOMMENDED.**

CANCELLATIONS/REFUNDS

Full refunds are available up to 90 days prior to departure, except for any nonrefundable deposits retained by our suppliers (i.e. air cancellation fees and any other applicable penalties). After this date the following cancellation fees will be assessed:

LUGGAGE

EXCLUSIONS

Not included are personal items such as additional food or beverage orders, room service, valet, laundry service, meals not listed as included, tipping for personal services not part of the tour's included features, end-of-trip gratuities for tour escort and driver, and any other items not specifically mentioned as being included.

These tours are under the management of Group TravelMasters of St. Paul, Minnesota. Group TravelMasters is responsible to you in making arrangements for the tour services offered in the brochure, including transportation, sightseeing and hotel accommodations as mentioned. Group TravelMasters reserves the right to accept or reject any person as a tour participant and to make changes in the itinerary wherever deemed necessary for the comfort, convenience and safety of the patrons, and to cancel a tour at any time. A refund for unused services is the limit of Group TravelMasters' liability if a person is requested to leave the tour. If Group TravelMasters cancels a tour, it shall have no responsibility beyond the refund of the monies paid to Group TravelMasters by the tour participant as listed. The tour participant agrees that neither Group TravelMasters or its affiliates shall be liable for any damages, loss or expense occasioned by any act of omission of any supplier providing tour services to any person.
