INTERIM MINISTER JOB DESCRIPTION

The Interim Minister will consistently assume all Sunday morning preaching duties (2 services – 8:30 contemporary usually held in the Community Center and 11:00 traditional in the sanctuary). The Interim will be allowed to be absent from the pulpit one Sunday per quarter served as needed for professional or personal obligations.

The Interim will address the spiritual needs of the congregation from the pulpit, including focusing on the Baptist faith and congregational healing; will lead discussions/listening sessions with members, working to facilitate communication and healthy discourse, will be available for and encourage member interaction.

The position will provide support for and assist with healing for ministerial staff.

The Interim minister will provide limited administrative leadership and support for administrative staff, Teams and Committees and serve as a member of Church Council. The Interim will be available in the church office, or in church service, during office hours of 9-4 Mondays and Tuesdays, in addition to Sunday commitments.

The Interim minister will assist with the pastoral search process including coaching the called search team and Personnel Committee as requested and/or led.

The Interim will be expected to take part in monthly Church Council meetings held the third Sunday of the month following the 11:00 service and Deacons meetings held the fourth Sunday of the month following the 11:00 service.

The Interim will be expected to participate in weekly staff meetings, currently held on Tuesday afternoons.

The Interim will be expected to be present and participate in quarterly church business meetings usually taking place the afternoon of the last Sunday of the months of January, April, July and October.
