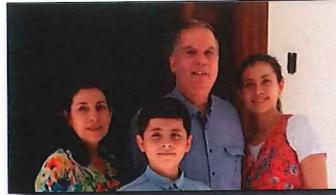


THE HART FAMILY IN COLOMBIA

Dearest Brethren,

It is a privilege to be writing you one again from Valledupar, Cesar, Colombia. Here, we are in the middle of a drought. It has only rained once since the first of November. It has been hot, windy, and dry.

Divine Help Needed

One of the problems that needs a lot of prayer is the situation with Venezuela. We are only 45 minutes away from the Venezuelan border. The second guerilla group in Colombia, (the ELN) has been entering and leaving Venezuela with tensions along the border. They have indicated loyalty to Maduro. It is unsafe to travel outside of Valledupar by car. The Colombian government is questioning about how many spies Maduro has sent here. There is a lot of tension with what is happening.

What's Going On At The Church

We have been evangelizing in a couple of barrios. The Catholics are being taught more about how to resist the true gospel. We have had a few interested in visiting and a couple of people that made professions of faith. At Church, we have been through a Synopsis of the OT and the NT. After finishing that, we have studied an overview of the Major Prophets. Some are in a second level book of discipleship. Also, I have been teaching about the need to evangelize and plan to teach the Book of Daniel.

Some Visiting Us

In February a couple visited us. The husband had part of his lung removed due to cancer. They want to be active in helping us in the Church at some time. Please help us pray about that. Our South American Director (Missionary Bruce Berry) was with us at the end of February. It was the first time someone from the U.S. had visited us here in Valledupar. His visit was a great blessing to all of us.

Need For Laborers

Please pray for the need for men to be trained in the ministry. Colombian laws require lots of red tape that require insurance, retirement, holiday pay, and severance pay in varying situations of having help in the ministry. Also, the legal obligations are such that the legal representative is liable and can be sued and even subjected to criminal prosecutions in some extreme cases.

Prayer For Us

Things have went well with home school. The kids are learning a lot and applying themselves. Please pray that we will be able to plan ahead and travel a bit when we need to. Even though we need to get some checkups done, we thank the Lord that we all are well.
