PARENT CONTRACT

- I. I acknowledge receipt of and agree to abide by the policies and procedures set forth in the parent's handbook.
- II. I understand that the teachers will teach Christian values and principles as taught in God's word. They will begin each day with prayer and devotion. As Christians, the teachers have committed their lives and this school to God.
- III. I understand that my child's tuition is due by the first of the month and I will be assessed a late fee of \$25.00 after the 10th day of the month. The tuition rate will not increase during the school year.
- IV. I understand that before my child enters school on the first day that all registration forms **must** be completed and turned in to the Preschool Director.
- V. I understand that each school year I am responsible to participate in 15 incentive hours. I further understand that if I do not participate or complete those hours, I am responsible to pay a fee of \$75.00. There will be an incentive sign-up sheet on the first day of school. I must sign-up or pay the \$75.00 fee by November 1st of the school year.
- VI. I understand that I am responsible for driving my child for all field trips. For further information on field trips, please refer to the Parent Handbook.
- VII. I understand that if I have a dispute with an individual that I must first seek a resolution with that person as outlined in Matthew 18:15. I am aware that if the matter is still unresolved, I can counsel with the Director and/or Preschool Team.
