

\$250,000 MATCHING GIFT

DEFINITIONS

1. This matching gift challenge will be referred to as the **“Challenge.”**
2. The Challenge is available 11/1/18 through midnight 6/30/20. This period of time will be referred to as the **“Term.”**
3. The Challenge amount available to Libertas Christian School is \$250,000. This amount will be referred to as the **“Match.”**
4. The individual making the Match available will be referred to as the **“Match Donor.”**
5. A donor who participates in the Challenge will be referred to as a **“Legacy Partner.”**
6. Each Legacy Partner must be identified by a unique identification code that cannot be reused by any other Legacy Partner. This identification code will be referred to as **“Legacy Partner Identification Code.”**
7. Each month during the Term a report must be submitted with an update on the progress of the Challenge. This report will be referred to as the **“Campaign Progress Report.”**
8. The date of the first donation made by the Legacy Partner will be referred to as the **“Start Date.”**
9. The last Campaign Progress Report submitted at the end of the Term will be referred to as the **“Final Campaign Progress Report.”**
10. The period of time after the Term and the submission of the Final Campaign Progress Report will be referred to as the **“Run Off Period.”**

RULES FOR PARTICIPATION

1. After the Start Date a Legacy Partner's donation will be matched a maximum of 12 times including the original donation made on the Start Date.
2. To qualify for the Challenge, the Legacy Partner must be a new monthly recurring donor to the school. Donors who are active on a monthly recurring basis before the Term cannot be included in the Challenge.
3. To qualify for the Challenge, the amount being matched must be a recurring monthly donation to the school.
4. To qualify for the Challenge, the Legacy Partner donation must be designated to a Libertas Christian School faculty or staff position, not a specific individual, or other expense. The Legacy Partner can designate the position, or the position can be designated by a representative of Libertas Christian School.
5. A Legacy Partner can increase or decrease the amount of their donation.
6. The Run Off Period ends on 7/1/21. No donation will be matched after this date.

REPORTING REQUIREMENTS

1. The Campaign Progress Report will be an inventory of all active Legacy Partners and include the following information.
 1. Legacy Partner Identification Code
 2. Legacy Partner Start Date
 3. Recurring monthly donation amount paid by Legacy Partner.
 4. Recurring monthly donation amount paid to date by Legacy Partner.
 5. A calculation of the Match amount due to be paid that month by the Match Donor.
2. The Campaign Progress Report will be submitted to the Match Donor by the 10th of each month.
3. The Match amount will be paid to Libertas Christian School within 15 business days of receipt of the Campaign Progress Report.
4. During the Run Off Period, the Final Campaign Progress Report will continue to be submitted monthly until the occurrence of either of the following:
 1. The Match amount has been used up.
 2. Each Legacy Partner donation has been matched 12 times.
5. During the Run Off Period, no new Legacy Partners can be added to the Final Campaign Progress Report, but Legacy Partner donation amounts can increase or decrease.

AGREEMENT

The Match Donor requests:

1. Strict anonymity.
2. Understanding that the Challenge Term will not be extended.
3. Understanding that the Match Donor wishes to bless Libertas Christian School and will be praying that the school take full advantage of the Challenge but requests not to be approached again for future donations.
4. Receipt of a copy of the 2017/18 fiscal yearend financial statement.
5. Receipt of a copy of the current year interim financial statement.
6. Receipt of a copy of the 2018/19 fiscal yearend financial statement when completed.
7. Receipt of a copy of the 2019/20 fiscal yearend financial statement when completed.
8. Receipt of a copy of the 2020/21 fiscal yearend financial statement when completed.
