As a volunteer I agree...

- » To abide by all state and federal regulations and safety procedures.
- » To freely donate my time and services to Calvary Bible Church.
- » That it is mutually and expressly understood that volunteer services shall be donated, and that I am not entitled to nor expect any present or future salary, wages, or other benefits for these voluntary services.



- » To follow the leadership and direction of any personnel, employee, or volunteer, to whom the volunteer has been assigned to perform services, and to participate in any training required by Calvary Bible Church in order to perform the voluntary services.
- » That I will not be considered to be an employee of Calvary Bible Church, for any purposes, while performing the above described voluntary services, therefore injury compensation or tort claims will not be covered by Calvary Bible Church insurance.
- » That if I am responsible for injuries to third parties or damages to their property while acting outside the scope of assigned volunteer duties, I may be held personally liable for any monetary damages a court may award to the injured party.
- » That the services rendered to Calvary Bible Church shall apply only in the case of liability arising out of the ordinary negligence that occurs during the scope of the volunteer's services agreed to herein, and that in no way do any of these provisions apply for the benefit of volunteer, his/her heirs, executors or administrators in any action arising out of gross negligence, willful misconduct, or any other conduct on my part, which cause or may give rise to criminal liability.
- » To fully cooperate with Calvary Bible Church and its agents in any investigation, lawsuit, arbitration, or any other legal or quasi-legal proceedings that arise from the matters covered by this agreement. I agree to notify Calvary Bible Church immediately of any incident that occurs or may occur within my knowledge, which gives rise to liability on my part as a volunteer of Calvary Bible Church.
- » That photographs and videos may be taken during the event. With respect to photographs and video taken of my child, individually or as part of a group (as applicable), I give permission for those videos and photographs to be used in any medium and for any purpose whatsoever including illustration, promotion, and advertising (excluding anything illegal or immoral).
