 APPLICATION FOR MINISTRY WITH MINORS

Thank you for indicating an interest in working with minors in one of our ministries. In addition to encouraging our children in their spiritual maturity, we have implemented a program designed to help:

- Safeguard the minors of our church from sexual molestation.
- Protect church staff and volunteer workers from potential allegations of sexual abuse.
- Limit the extent of our church's legal risk and liability due to sexual abuse.
- To these ends we have adopted a process of "worker selection" for all paid staff and those volunteers who will be working with minors (children under the age of 18).

BECAUSE OF YOUR INTEREST IN WORKING WITH MINORS, WE ARE REQUESTING THAT YOU COMPLETE THIS APPLICATION AND RETURN IT AS SOON AS POSSIBLE.

ANSWERS TO SOME QUESTIONS YOU MAY BE ASKING:

WHAT IS INVOLVED IN THE "WORKER SELECTION PROCESS?"

All paid staff and those volunteers working with minors complete the APPLICATION FOR MINISTRY WITH MINORS. This application provides information used in the placement of the individual and authorizes both personal reference and criminal record checks to be conducted on the applicant.

HOW WILL IT BE DETERMINED WHETHER AN INDIVIDUAL IS APPROVED TO WORK WITH MINORS?

We are committed to placing individuals who have no record of previous conviction for child sexual or physical abuse; for whom we receive positive responses from their personal and professional references; who have been affiliated with the church for at least six months; and who meet the qualifications of the position for which they are applying. received that is questionable, the individual will be asked to meet with a Solid Rock Bible Church (to be referred to as SRBC) staff member to clarify the questionable issues prior to being placed in a position that relates to minors.

WHAT ABOUT CONFIDENTIALITY?

The completed APPLICATION FOR VOLUNTEER MINISTRY WITH MINORS and any subsequent information on the applicant will be available only to the Financial Office, designated SRBC Staff members and, if deemed necessary, the elders of SRBC. Once the approval process has been completed, these documents will be maintained in a secure file location. Please attach a photocopy of your driver's license with the application. We will be happy to make a copy for you in the church office. If you admit to engaging in sexual misconduct with a minor, however, we will be required to follow applicable law regarding child abuse reporting.

WHAT CAN I DO TO HELP?

Implement and enforce supervisory policies and procedures in your ministry area. Follow the "two adult" rule (two adult supervisors should be present during any church activity).

This rule reduces the risk of sexual molestation and also reduces the risk of false accusations of molestation by individuals seeking a quick legal settlement. Avoid going out alone with a child or spending time with a child in an unsupervised situation. Discuss suspicious behavior, allegations, or symptoms of child abuse immediately with your SRBC Staff representative. Any inappropriate conduct or relationship between an adult worker and member of the youth group or a child should be reported to your supervisor, confronted immediately and investigated. Scripture directs us to be above reproach. There is a cost in safeguarding our children. However, when compared to the impact that one case of sexual abuse would have to the lives of individuals and to our overall ministry, this cost is well justified.
