Biblical Authority and Understanding	We affirm the Bible is the inspired, infallible, authoritative Word of God, we are living within God's redemptive-historical story that is constructed and governed by God's covenants and promises, understanding the Bible correctly requires use of consistent exegetical principles that include the grammatical/literary, historical, language and theological dimensions, the illumination of the Holy Spirit, the author who sits with us every time we open his bestselling book. Recognizing the symbolic cleansing and refreshing characteristics of water, the RCA affirms sprinkling, immersion, and pouring as methods of baptism. In the Reformed Church, baptism is always performed in the context of a congregation of God's people. The congregation commits itself to the spiritual nurture of the infant, child, or adult being baptized. Baptism is the mark of corporate faith as well as individual faith. The sacrament of baptism shall be administered, if possible, at a time and place of public worship. "The Order for the Administration of Baptism" shall be read. It shall consider requests for infant baptism, providing at least one parent or guardian is a confessing member of the church to which the request is presented. A request for baptism from a parent or guardian who is not a confessing member of the church to which the request is made shall first be submitted for approval to the governing body of the church where the parent or guardian has membership.

Historically, Reformed worship services have a particular flow that reflects our encounters with God: approaching God, receiving the Word of God, and responding to God. Homosexual Marriage	We affirm the Great Lakes Catechism on Marriage and Sexuality as a confessional appendix to the Heidelberg Catechism so that its affirma)ons regarding human sexuality are read within the context of the Heidelberg Catechism's teachings on sin, salvation, and service.	We intend to defend and celebrate a biblical view of sexuality. Man is for woman and woman is for man. Heterosexual marriage is the space for the good sexual intimacy. General Synod 2017 voted "to affirm that the Heidelberg Catechism Q&A 108 and 109 categorically states that God condemns 'all unchastity,' which includes same-sex sexual activity, and that faithful adherence to the RCA's Standards, therefore, entails the affirmation that marriage is between one man and one woman." The 2018 General Synod responded to overtures from two classes and a regional synod by approving a recommendation: To commend the Great Lakes Catechism on Marriage and Sexuality for reflection, study, and response by the Commission on Theology and RCA churches and classes as a means of deepening our understanding of the biblical teaching on human sexuality and finding a pathway forward toward unity in mission and ministry. (OV 18-21, MGS 2018: 148) General Synod 2019 declined to receive the Great Lakes Catechism on Marriage and Sexuality as a "catechism" based on the Commission on Theology's review of the document, instead instructing that it be referred to as a "teaching tool" in future denominational references.
Financial Expectations	Plan as of 2/6/22 meeting is: 1% of Community Reformed Church income to National/Global Alliance, 2% of Community RC Income to Network office. Dollar amount determined quarterly based on individual church income using that 3% plan. The Network shall have no claim against such member church property.	Whenever a church is disbanded and the corporation or other legal entity through which its consistory functions is dissolved, all real and personal property shall thereupon become vested in the classis with jurisdiction over the church, upon the assumption by the classis of all that church's outstanding obligations, provided the laws of the state in which the church is located do not prohibit this procedure. If the classis is not legally capable of owning real property, all such real and personal property shall become vested in the next higher assembly legally capable of owning real property, upon the assumption by that assembly of all outstanding obligations of the church. The assumption of obligations shall be limited to the value of such property.
