## WHAT DOES IT MEAN TO BE A SERVANT LEADER

Elected Leadership Positions

## Leadership Council / Mutual Ministry Committee / Nominating Committee

"Sitting down, Jesus called the Twelve and said, "Anyone who wants to be first must be the very last, and the servant of all." Mark 9:35

Accepting a leadership position is a commitment to actively serve the church and community. Those seeking nomination for an elected leadership position must have a Membership Covenant on file.

#### Leaders are to:

- Faithfully communicate with Council, Staff and Volunteers. Good consistent communication is key.
- Faithfully pray for their area of ministry and Crossroads.
- Encourage one another, other volunteers and staff.
- Actively pursue their personal spiritual growth through opportunities offered at Crossroads.

### **Leadership Council Members (LC)**

- 1. Leaders are to faithfully take an active role in supporting their area of ministry;
  - Each Leadership Council member is assigned as a liaison to one or more ministry teams (see liaison duties). In addition Leadership Council members may be elected by Council to serve as Chair, Vice Chair, Financial Officer, or Secretary, appointed to serve on either Mutual Ministry Committee, Nominating Committee or other special committees according to the Bylaws of the church.
- 2. Leaders are to faithfully attend meetings;
  - Monthly Council Meetings, Congregational Meetings, Ministry Team Leaders Meetings, Ministry Team meetings as it relates to liaison position.
     Preparedness for these meetings is essential (read materials ahead of time).

## **Mutual Ministry Committee (MMC)**

- 1. Committee Members are to faithfully take an active role in supporting their area of ministry;
  - Mutual Ministry Committee is chaired by the Vice Chair of the church as according to the church Bylaws. Committee members may be assigned a staff person(s) to encourage/support throughout the year by meeting with them in a confidential setting.
- 2. Committee Members are to faithfully attend meetings;
  - Committee meetings, Congregational Meetings, Ministry Team Leader Meetings.

# **Nominating Committee Members (NC)**

- 1. Committee Members are to faithfully take an active role in supporting their area of ministry;
  - Members of this committee may be elected by the committee to chair the committee. All members are to take an active role in the nominating process (see nominating process).
- 2. Committee Members are to faithfully attend meetings;
  - Committee meetings, Congregational Meetings, Ministry Team Leaders Meetings.
