



Volunteer Assumption of Risk, Waiver of Liability & COVID-19 Agreement

By signing, I am willing to volunteer with Feeding America, Kentucky's Heartland (FAKH) with the following understanding:

- I attest that I am not experiencing any of the CDC-recognized COVID-19 symptoms, including:
 - cough
 - shortness of breath or difficulty breathing
 - fever
 - chills
 - muscle pain
 - sore throat
 - new loss of taste or smell

If I develop these symptoms, I agree that I will notify the FAKH Volunteer Coordinator for possible contact tracing.

- I attest that:
 - I have not traveled internationally in the past 14 days.
 - I have not traveled to a highly-impacted area within the United States in the past 14 days.
 - I do not believe that I have been exposed to a person with a confirmed or suspected case of COVID-19.
 - I have not been diagnosed with COVID-19 and not yet cleared as non-contagious by state or local public health authorities.
 - I am following recommended guidelines as much as possible - practicing social distancing by participating in group activities of fewer than 10, trying to maintain separation of six feet from others, and otherwise limiting my exposure to the coronavirus.
- In the interest of public safety and the safety of FAKH employees and volunteers, I give permission for my temperature to be taken upon entry into the Volunteer Center or other designated FAKH facility. If my forehead scan temperature reading is 100.4° Fahrenheit or higher, FAKH reserves the right to ask me and/or my group to leave and not volunteer at that time. A volunteer with a temperature of 100.4° Fahrenheit or higher must be cleared by a medical professional before volunteering can begin on another date.
- I agree to abide by FAKH safety and sanitation standards. To the greatest extent permitted by applicable law, FAKH shall not be held liable if I contract COVID-19 from volunteering at the FAKH Volunteer Center or by participating at one of its affiliated sites.

- By volunteering, I acknowledge I will be interacting with others in close proximity and handling different types of items in closed spaces. I understand that these close interactions and handling of items could expose me to pathogens and other harmful germs and viruses, that I could become sick from them, and that I could foreseeably suffer personal injury, sickness, or death, as a result of my exposure to them. Notwithstanding, I assume the risk that these threats pose and knowingly volunteer despite them.

Assumption of Risk and Waiver of Liability

I acknowledge that I have willingly volunteered with Feeding America, Kentucky's Heartland. I understand the scope of my volunteer relationship Feeding America, Kentucky's Heartland is limited to a volunteer position and that no compensation is expected in return for services provided by me; that Feeding America, Kentucky's Heartland will not provide any benefits traditionally associated with employment; and that I am responsible for my own insurance coverage in the event of illness or personal injury as a result of my services to the Feeding America, Kentucky's Heartland.

I hereby agree to hold Feeding America, Kentucky's Heartland and its agents harmless from any past, present, and future claims, actions, demands, liability, rights, damages or losses, including those for personal injury, sickness, death, and any property damage, that I, my beneficiaries, administrators, executors or assigns had, have now or may have in the future in connection with my volunteer activities. I agree to hold Feeding America, Kentucky's Heartland and its agents harmless from any claim by any third party arising out of any inaccuracy or breach of any representations and warranties herein.

I understand that my volunteer activities with Feeding America, Kentucky's Heartland may include activities that could be hazardous to me, including but not limited to packing, loading, unloading and carrying heavy items, transportation to and from work sites, and exposure to people with infectious diseases. I further hereby knowingly, freely, and voluntarily release, hold harmless, and absolve Feeding America, Kentucky's Heartland, and any related or affiliated agencies, organizations, employees, agents, board members, volunteers, contractors, and other associated individuals or entities of and from any and all liability whatsoever concerning my volunteering for, at, or related to Feeding America, Kentucky's Heartland.
