# MINUTES OF THE PENNYRILE AREA DEVELOPMENT DISTRICT BOARD OF DIRECTORS VIRTUAL MEETING

### MARCH 8, 2021 AT 1:00 P.M.

- I. CALL TO ORDER: Judge Perry Newcom, Board Chair, called the meeting to order at 1:04 p.m. and recognized a voting quorum. Due to the current State of Emergency regarding threats to public health presented by the novel coronavirus (COVID-19) pandemic, this meeting was conducted by videoconference (Zoom).
- **II. PLEDGE/INVOCATION:** Ms. Deb Domke led the pledge and Mr. Bernard Standard led the invocation.
- III. MINUTES: Minutes of the February 8, 2021 Board Meeting was presented for review and approval. A copy was included in the online board meeting packet and a copy is attached to and made a part of these minutes. There were no questions or concerns, **Motion** made by Judge Perry Newcom to approve the February 8, 2021 minutes as presented; motion carried.
- IV. APPROVAL OF FINANCIAL REPORT: Ms. Crissy Carter, Board Treasurer, presented the February 28, 2021 Monthly Expenditure Report for review and approval. A copy was included in the online board meeting packet and a copy is attached to and made a part of these minutes. Overall, all line items are within the operating budget at \$2,210,094.53 (54.57% vs. 66.67%) year-to-date. There were no questions or concerns. Motion made by Judge Steve Tribble to approve the financial report as presented. Mr. Bart Frazer seconded the motion and the motion carried.

#### V. FEDERAL AND STATE REPORTS:

- 1. <u>U.S. Senator Mitch McConnell/Morgan Alvey</u> Ms. Morgan Alvey, Field Representative, reported the \$1.9T stimulus bill passed with Democrats in favor and Republicans against (in contrast to last year) in part to due to the lack of non-COVID related funding included. Only 9% of funding is designated to the health care fight against COVID-19 and only 1% to vaccinations. In terms of getting children (K-12) back into school, only 5% of funding is designated and the bill will go back to the House and Senate for revision later this week. Their office has been tracking damage caused by the recent flooding. Please let them know if you have any questions regarding the FEMA Disaster Declaration process or need assistance. There were no questions or concerns.
- 2. <u>U.S. Senator Rand Paul/Jon Crosby</u> Mr. Jon Crosby, Field Representative, reported through the parliamentary process, Senator Paul identified non-COVID related funding in the stimulus bill that was removed by the Democrats. Jason Hasert's recovery from COVID-19 is going well and he hopes to be back in the office in the very near future. There were no questions or concerns.

- 3. <u>U.S. Congressman James Comer/Corey Elder</u> Mr. Corey Elder, Field Representative, reported their office has also been tracking flood damage and last week he visited areas in both Christian and Todd counties. There are a lot of FEMA resources available that we can provide should you need assistance. Congressman Comer is concerned about excessive spending and allocation of funding designated to COVID-19 in the stimulus bill. We need to be smart about spending and ensure those that need help are getting it. There were no questions or concerns.
- 4. <u>KY State Representative Melinda Gibbons Prunty</u> Rep. Melinda Gibbons Prunty reported there are six days remaining in the legislative session in Frankfort. They have passed bills to help revive the economy and continue to work on legislation regarding the Governor's executive powers. They continue to hear about unemployment issues and are in the process of passing legislation to provide unemployment insurance relief to small businesses. We need to protect people who were overpaid at no fault of their own. Work continues on passing a state budget by the end of this week which may end up being a continuation of the previous budget. She was excited to attend the announcement by Madisonville Community College regarding their new aviation program to train both helicopter and fixed-wing pilots with simulators housed at both Madisonville Regional Airport and Muhlenberg County Airport. This is a great educational and job opportunity for our district. There were no questions or concerns.
- 5. <u>Kentucky Transportation Cabinet (KYTC)/Deneatra Henderson</u> Ms. Deneatra Henderson, KYTC Chief Engineer, District 2, reported this is "pot hole" season, especially in high traffic locations. The Transportation Department is aware of problem areas and are addressing them, sometimes even twice a day. If there is an area of concern in your county, please let us know. There were no questions or concerns.
- 6. <u>Department for Local Government (DLG)/Elton Thomas</u> Mr. Elton Thomas, DLG Field Representative, reported the COVID-19 vaccination process is going well and we are seeing a decline in positive cases. State parks have receive funding for improvements in twelve counties. The Delta Regional Authority (DRA) application process for funding is now open. There were no questions or concerns.
- 7. <u>KYTC Department for Rural & Municipal Aid/Doug Taylor</u> Mr. Doug Taylor, Field Representative, stated if you have any questions regarding the Emergency Co-op Program, please contact him. There were no questions or concerns.

#### VI. REPORTS:

- 1. <u>Area Agency on Aging & Independent Living</u> Ms. Jill Collins, Director, Pennyrile AAAIL, provided the following report:
  - <u>FY19-21 Area Plan Revisions</u> a copy of the revisions to the FY19-21 Area Plan was provided in the online board meeting packet; a copy is attached to and made a part of these minutes. Ms. Collins stated the revised plan will be submitted to the Department of Area Agencies on Aging & Independent Living (DAAIL) at the end of this month. There were no questions or concerns.
  - <u>National Social Work Month</u> the month of March celebrates Social Work and Social Workers. An article is included in the March newsletter and we would like to recognize all of our social workers and thank them. They are essential to the connection between clients and services. Informational.
  - <u>Aging Waiting List</u> a copy of the Aging Waiting List as of March 2, 2021 was provided
    in the online board meeting packet; a copy is attached to and made a part of these
    minutes. Clients on the waiting list are currently being served home delivered meals until
    COVID funding is depleted. Informational.

- <u>Senior Citizen Centers</u> DAAIL released a draft plan for input/discussion regarding reopening of the Senior Citizen Centers. We will submit our responses to them today. As of right now, no date has been set. There were no questions or concerns.
- <u>Pennyrile AAAIL Meal Update</u> As of 2/23/2021, a total of 250,575 hot meals were served to clients age 60 plus, which is an average of 1,100 meals per day. We are thankful to our provider, PACS, for the great job they are doing. We have seven clients who elected to place their services on hold due to the pandemic; we continue to check on them to ensure their other needs are being met. There were no questions or concerns.
- <u>COVID-19 Vaccinations</u> we have started receiving calls through our ADRC program to assist individuals with finding a vaccination site in their area and connecting them to that location. There were no questions or concerns.
- 2. <u>Community & Economic Development</u> Ms. Amy Frogue, Associate Director CED, provided the following report:
  - <u>Funding Opportunities</u> Ms. Frogue gave a slide presentation overview of Delta Regional Authority (DRA) State's Economic Development Assistance Program (SEDAP) funding available through the 2021 Federal Grant Program and reviewed criteria for eligible applicants, eligible activities, application requirements and deadlines. A copy of the slide presentation and criteria was provided in the online board meeting packet; copies are attached to and made a part of these minutes. There were no questions or concerns.
  - <u>IGR Report</u> a copy of the IGR Report was provided in the online board meeting packet; a copy is attached to and made a part of these minutes. One project has been submitted for review for the City of Mortons Gap. There were no questions or concerns.
- 3. <u>West Kentucky Workforce</u> Ms. Sheila Clark, Director, WKWB, provided the following report:
  - <u>Labor Market Snapshot</u> data for the Labor Market Snapshot report has not been released yet; we will have a report to present next month.
  - <u>WIOA Comprehensive Regional & Local Workforce Strategic Plan</u> Ms. Clark reported the Workforce Innovation Opportunities Act (WIOA) planning process began this month, both locally and regionally, to develop a five year strategic plan. Final draft plans will be available for public review with a 30 day comment period on or about April 30, 2021. There were no questions or concerns.
  - <u>KY Career Centers</u> discussions continue with the Kentucky Labor Cabinet and partner agencies regarding setting a date to resume face-to-face appointments at Career Centers as long as CDC guidelines can be followed. More information will be forthcoming. There were no questions or concerns.
  - <u>Upcoming Events</u> the Education & Workforce Development Cabinet Virtual Bus Tour is scheduled for Wednesday, March 10 at 2:00 p.m. The virtual tour will showcase ten local workforce areas in KY as well as partner agencies, special programs, and job opportunities in the region. A Regional Entrepreneur Conference will be held on Wednesday, March 10 from 9:00 a.m. to 2:30 p.m.; an informational flier was provided in the online board meeting packet and a copy is attached to and made a part of these minutes. The next West Kentucky Workforce Board (WKWB) meeting is scheduled for Friday, March 12 at 10:00 a.m. via Zoom. There were no questions or concerns.
  - <u>Request for Proposals</u> Ms. Clark reviewed a Request for Proposal One-Stop Operator and a Request for Proposal Direct Services. A copy of both RFPs was provided in the online board meeting packet; copies are attached to and made a part of these minutes.

Ms. Clark reviewed the bid timetable. Contract periods are for July 1, 2021 – June 30, 2025 and the response deadline is April 26, 2021 at 1:00 p.m. (CDT). There were no questions or concerns.

#### VII. NEW BUSINESS:

- 2. <u>Monthly Code of Ethics Report</u> Judge Newcom, Board Chair, stated no violations have been reported during the month. Informational; no action required.
- 3. <u>Guest Speaker</u> Judge Newcom, Board Chair, welcomed and introduced guest speaker Ms. Nancy Brown, PMP, State Director, Kentucky Procurement Technical Assistance Center (KYPTAC). Ms. Brown gave a slide presentation overview of the organization's mission, State-wide services, and Federal funding dependent upon KY Match. KYPTAC promotes inclusive economic development by assisting companies to sell to Federal, State and Local government, as well as helping them to access subcontracts with large contractors. Their goal is to help Kentucky businesses enter & compete in the government space and the services they offer are free of charge. There were no questions or concerns.
- 4. West Kentucky Coalition (WKC) Judge Jack Whitfield, WKC Board Chair, provided an update on the organization's activities. We are seeing good membership representation from the counties in our region, but only 30% of the cities in our region are participating. He encouraged County Judge Executives to reach out to their cities. The board recently held a virtual meeting to discuss efforts to support legislation they would like to see get passed by working with our legislators in Frankfort. There were no questions or concerns.
- 5. <u>Director's Report</u> Mr. Jason Vincent, PeADD Executive Director, expressed appreciation to Ms. Brown for her presentation; we look forward to working with KYPTAC in the future. Mr. Vincent provided the following report:
  - <u>HB561</u> Mr. Vincent asked Mr. John Mahre, PeADD Regional Transportation Committee Chair, to provide an update on HB561. Mr. Mahre reported the bill seeks to set a single excise tax on gas and special fuels at an initial base rate of 34.6 cents per gallon with an index up to 10% per fiscal year, establish a base highway user fee for non-hybrid electric vehicles at \$150, and \$75 for hybrid vehicles. The bill is currently being reviewed by the KY House, but the legislative session will be ending in a matter of a few days. Both the Kentucky Transportation Cabinet and the Kentucky Chamber of Commerce are working hard to bring about awareness. Please contact your local State representatives to voice support of this bill. Rep. Prunty stated she understands the need for the gas tax increase; however, expressed concern regarding the burden a tax increase places on individuals who are already struggling financially due to unemployment. There were no questions or concerns.
  - <u>State Budget</u> the KY General Assembly began meeting to develop the state budget just a few hours ago. The legislative session is scheduled to conclude on Tuesday, March 30. Informational.
  - <u>HB367</u> this bill will add public employment offices in specific areas when the local workforce area has an unemployment rate above 5%. The bill has been passed by the KY House and is being reviewed by the KY Senate, but may be stalled due to the cost of reopening these offices. Rep. Prunty stated she has talked with several legislators and offices need to be located strategically with consideration to cost. There were no questions or concerns.
  - <u>SB276</u> this bill creates a KY Education and Workforce Collaborative to implement policies and provide oversight of and decision making by workforce boards at the local level. It has been introduced, but may be stalled in committee. There were no questions or concerns.

- <u>HB320</u> this bill will provide flexibility for electric cooperatives in broadband development and distribution. Last year, the PeADD Board of Directors approved a resolution in support of this bill, specifically noting Kenergy Corporation. There were no questions or concerns.
- <u>KY HCR55</u>- this legislation creates a Home & Community Based Services Waiver Redesign Task Force to review previous waiver redesign efforts and develop recommendations to ensure the quality and stability of waiver services in KY. Currently, we provide 20% of these services across the state and Area Development Districts do not have representation on the task force. We hope to see this change and Rep. Prunty has been helping in this effort. There were no questions or concerns.
- <u>Annual Dinner Meeting</u> the June Annual Dinner meeting will be moved to Monday, September 13, 2021 in hopes of holding an in-person celebration event. A regular business meeting of the Board of Directors will still take place on Monday, June 14 and will serve as the annual meeting. Please note this change on your calendars. We have started to sign contracts with venues and are making plans to hold in-person events this year such as the Pride of Pennyrile Industry Appreciation event and the Annual Board Christmas Luncheon. Plans will be adjusted as needed per COVID guidelines. There were no questions or concerns.
- <u>PADD Press Newsletter</u> a copy of the March 2021 issue of the PADD Press was provided in the online board meeting packet and it is full of great information this month. Next month's issue will include an article about Madisonville Community College's new aviation program and thanks to Rep. Prunty for mentioning it. It is a great opportunity for our region especially with Fort Campbell in close proximity. There were no questions or concerns.

### **Electronic Visit Verification (EVV)**

On January 29, 2021, The Department for Medicaid Services (DMS) released a statement informing all waiver providers the new go-live date is April 1, 2021. However, on March 16, 2021, providers received a letter from DMS reporting they are concerned about the impact of the EVV system on waiver providers and participants due to identified performance issues with function, efficiency, reliability, and intermittent slowness in both Tellus EVV application and Provider Portal. As a result, DMS has decided to pause the required use of Tellus EVV and a new date will be set in the upcoming weeks.

# Home & Community Based Waiver (PDS/ Traditional) and Veterans Directed Care Update.

Participant Directed Services (PDS) / Home and Community Based Waiver is an alternative to the traditional service delivery model under the Medicaid Waivers. The PDS program is designed to allow clients to have more choice, flexibility and options regarding their in-home waiver services. Currently Pennyrile AAAIL is serving over 238 active HCB clients, and has 60 clients currently in the pending status. The Veterans Directed Program (VDC) has the same goal of preventing or prolonging someone being placed in a long-term care facility by providing non-skilled services in the veteran's home. There are currently 83 active veterans in the VDC Program and 4 currently in the pending status.



On March 10, 2021, the Centers for Medicare and Medicaid Services (CMS) issued revised visitation guidance. The guidance eases some of the restrictions on general indoor visitation while maintaining much of the guidance from September 17, 2020. To see the complete revised CMS document visit:

### **Highlights include:**

- Facilities should allow indoor visitation at all times and for all residents except in certain specific circumstances.
- There are now fewer circumstances under which indoor visitation can be completely suspended.
- Fully vaccinated residents can have close contact, including touch, with visitors as long as they wear a mask and practice hand hygiene.
- Visitors should not be required to be tested or vaccinated as a condition of visitation.
- CMS continues to emphasize that facilities shall not restrict visitation without a reasonable clinical or safety cause and that nursing homes must facilitate inperson visitation consistent with the federal nursing home regulations.
- Visitation must be person-centered and "consider the resident's physical, mental, and psychosocial well-being, and support their quality of life."
- Before your first indoor visit it is still recommended to call the facility first and inquire about their specific policy for indoor visitation.

Re: President Biden's Announcement of New \$100 Million Investment in

the Aging and Disability Networks to Support COVID-19 Vaccination

For more than a year, n4a has been championing the COVID-19-related needs of the older adults you serve and your individual and collective ability to meet those needs—with appropriate resources. With a total of \$2.7 billion in emergency federal funding secured for the Older Americans Act in the past year, our advocacy efforts and your implementation have been tremendously successful.

But the work is still far from over. For several months, n4a has been talking non-stop to Congress, the Biden Administration, the CDC and the media about the role you have been playing or are poised to play in supporting the vaccination of older adults. This n4a advocacy led to hundreds of millions of additional dollars in the American Rescue Plan Act for OAA Title III B Supportive Services to support those efforts.

### Today brought even more recognition of your work and our advocacy!

President Biden <u>announced today</u> that an additional \$100 million has been allocated from CDC to ACL to support the efforts of the aging and disability networks in assisting with vaccination—from scheduling to providing supportive services such as transportation and on-site assistance. (Read the <u>HHS press</u> release.)

Of that amount, \$50 million will go to the Aging Network via state units on aging and then to AAAs, and an additional \$26 million will be made available to ADRCs. ACL reports that the \$50 million for the Aging Network will be distributed via the Older Americans Act Title III funding formula and the hope is that allocations will be made to states within two weeks.

The Eldercare Locator, which n4a operates for the U.S. Administration on Aging, will receive \$2 million to provide Information and Referral assistance to older adults who are homebound or otherwise do not have anyone who can support them in navigating the often-complex vaccination process, and additional funding to use the Eldercare Locator's infrastructure to support the build-out of a disability-focused call center. While the direct services, such as transportation or companion care at vaccination sites, will be provided by the aging and disability networks on the ground, the Eldercare Locator's role is to help the most in-need people connect to you.

More details will emerge soon and n4a will keep you posted as we learn more, but I want to thank you for the incredible dedication you and your staff and volunteers have shown during this long year of responding to COVID-19. n4a will continue to fight for AAAs so you can continue to meet the needs of older adults, people with disabilities and their caregivers, now and in the future.

# Gov. Beshear: In-Person Unemployment Appointments Open April 7, Services Begin April 15

After being closed for more than three years, regional offices to reopen for in-person unemployment insurance assistance

**FRANKFORT, Ky. (April 6, 2021)** — Gov. Andy Beshear and Labor Cabinet Secretary Larry L. Roberts announced today that in-person unemployment insurance (UI) services will open April 15 at more than a dozen regional Kentucky Career Centers (KCCs).

KCC staff will be available for in-person assistance by appointment only. At 1 p.m. EDT tomorrow, April 7, Kentuckians can begin scheduling Monday through Friday appointments at <a href="https://kcc.ky.gov">kcc.ky.gov</a>.

Openings tomorrow will be for appointments April 15-30. Beginning April 19, appointments for May 3 will become available, with additional appointment times opening each day thereafter.

"When you combine years of painful staffing cuts, an out-of-date system designed to tell people no and the effects of a once-in-100-years pandemic – many Kentuckians have been unable to obtain benefits," Gov. Beshear said. "In addition to taking many new actions to help Kentuckians in need, we are now making good on our promise to begin putting unemployment specialists back into the local career centers."

Labor Secretary Roberts said the Kentucky Career Center staff is working diligently to prepare for opening day.

"It has taken a lot of work to make it happen in a short window of time, but our staff has worked hard in recent weeks to pull everything together to get us in a position to once again provide services that unemployment claimants need at this critical time," Roberts said.

Under the previous administration, KCC locations around the state stopped providing in-person assistance to UI claimants in the fall of 2017.

The record level of unemployment spurred by the pandemic and years of painful staffing cuts, location reductions and failure to upgrade IT systems slowed the state's ability to help many Kentuckians who lost jobs through no fault of their own.

The Governor's proposed budget included General Fund spending of \$1.1 million in fiscal year 2021 and \$8.4 million in fiscal year 2022 to provide funding to restore employees to help with unemployment claims at the career centers throughout the commonwealth.

On March 31, Gov. Beshear spoke about the need for additional state funding to bolster career center staffing for the long term. The Labor Cabinet will be utilizing

current staff in the career centers that normally provide career counseling services to begin offering in-person UI assistance.








### American Jobs Plan Proposal Includes Provisions for Rural America

On March 31, the Biden Administration unveiled a more than \$2 trillion infrastructure proposal called the *American Jobs Plan*, which aims to tackle issues including transportation, infrastructure, green energy, healthcare, and childcare, among other priorities. This is the first

proposal released as part of a two-pronged infrastructure package; a second proposal is expected to be revealed sometime in April.

The Biden Administration also published a White House Fact Sheet detailing provisions in the infrastructure plan that are intended to serve rural America specifically. The fact sheet highlights:

- A proposed investment of \$14 billion split among three agencies: the U.S. Economic Development Administration (EDA), the U.S. Department of Commerce, and the U.S. Department of Housing and Urban Development, for investments in rural America's physical, social, and civic infrastructure
- A proposed investment of \$5 billion in a "Rural Partnership Program" focused on rural regions and inclusive community and economic development
- \$100 billion to expand broadband infrastructure across the nation, including funding to provide coverage in rural America
- More than \$10 billion in grants and loans for small and rural water systems
- A proposed \$10 billion Community Revitalization Fund to support innovative, community-led redevelopment projects in rural and urban areas that spark new economic activity
- \$20 billion over five years to repair smaller, off-system, and rural bridges
- And many other provisions

### President's FY 2022 Budget Request Released Today

Today, President Biden released his <u>FY 2022 Presidential Budget Request</u>. The overall price tag of the President's proposed budget for FY 2022 is more than \$1.5 trillion. The release of the President's budget proposal today serves as the foundation for the negotiation process between the President and Congress to determine the distribution of funds across the government for FY 2022. The President's proposed budget recommends \$384 for the U.S. Economic Development Administration, which would be a \$38 million increase over EDA's FY 2021 appropriation if enacted.

# Gov. Beshear Announces Projects to Receive Recreation Funding

The Department of Local Government (DLG) awarded funding for a Recreational Trails Project (RTP) in the Pennyrile area this month.

<u>City of Madisonville</u> - \$20,000 for improvements to Cherry Park for a paved walking trail and restroom facility.

RTP is a competitive, federal program which provides assistance for easement acquisitions, trailhead facility upgrades, and recreational trail development and maintenance.



On March 29, Governor Andy Beshear announced the selection of 41 projects totaling more than \$4.3 million to receive funding from the Land and Water Conservation Fund (LWCF). The LWCF is a federal program designed to help local communities improve outdoor recreation spaces. The following Pennyrile communities received funding:

<u>City of Drakesboro</u> - \$125,096 for playground equipment at the city park

<u>City of Eddyville</u> - \$50,140 to renovate tennis courts at the city park

<u>City of Hopkinsville</u> - \$75,000 to construct group shelters and a playground at Pardue Lane Park

<u>City of Kuttawa</u> - \$125,100 to expand and upgrade Glenn Park

 $\underline{\text{City of Nortonville}}$  - \$125,100 to renovate and upgrade the city park

<u>Christian County</u> - \$25,000 to assist with a covered pavilion at Jeffers Bend Environmental Area

<u>Livingston County</u> - \$150,000 to upgrade Ledbetter Community Park

<u>Todd County</u> - \$250,000 for property acquisition to construct a soccer field complex

<u>Trigg County</u> - \$125,245 for a restroom facility at the Trigg County Recreation Complex

### **Medicare Beneficiaries**

Are you currently receiving Medicare and paying for your Part B monthly premium? If so, there is a program that may be able to assist you with that premium cost. If your income is under \$1,456/single or \$1,960/married and your resources/assets are under \$7,860/single or \$11,800/married then you may qualify to receive assistance through the state with a program called the Medicare Savings Program. This program may help pay for your Part B premiums and *potentially* assist in also paying for Part A premiums, deductibles, coinsurance, and copayments, depending on your income level. On March 10, 2021, the Centers for Medicare and Medicaid Services (CMS) issued revised visitation guidance for nursing homes. The guidance eases some of the restrictions on general indoor visitation while maintaining much of the guidance from September 17, 2020. #### **Highlights include:**

- Facilities should allow indoor visitation at all times and for all residents except in certain specific circumstances.
- There are now fewer circumstances under which indoor visitation can be completely suspended.
- Fully vaccinated residents can have close contact, including touch, with visitors as long as they wear a mask and practice hand hygiene.
- Visitors should not be required to be tested or vaccinated as a condition of visitation.

- CMS continues to emphasize that facilities shall not restrict visitation without a reasonable clinical or safety cause and that nursing homes must facilitate in-person visitation consistent with the federal nursing home regulations.
- Visitation must be person-centered and "consider the resident's physical, mental, and psychosocial well-being, and support their quality of life."
- Before your first indoor visit it is still recommended to call the facility first and inquire about their specific policy for indoor visitation.

### **Senior Center Update**



After one year of the COVID-19 pandemic, the nine senior centers in the Pennyrile region continue to be closed in an effort to help prevent the spread of COVID-19. Curbside meal pick-up at all nine senior centers continues to be an alternative option to congregate meals (lunch meals served at senior centers).

State and federally funded home delivered meals continue to be provided in all nine counties and an additional 1,220 individuals have received home delivered meals based on increased federal funding related to COVID-19. From March 16, 2020 to March 26, 2021, a total of 2,168 clients in the Pennyrile region were provided with 285,594 meals. This is a dramatic increase from prior years which averaged 150,051 meals.

Additional services such as homemaking and personal care continue to be provided, following CDC guidelines related to COVID-19, with federal and state funding to individuals in the Pennyrile region. Currently, there is a waiting list for in-home services. Individuals needing meals or in-home assistance can contact the Pennyrile Aging & Disability Resource Center at 1-866-844-4396 for more information, eligibility screening, and referral to potential services/programs.
