MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is established between DAN Southern Africa a non-profit organisation and the undersigned dive business and their representatives. The MoU authorises the dive business to enrol its dive clients under the DAN Resort Membership programme which includes the following:

Automatic cover for all dive clients without any individual registration needed. This will require a trust relationship between DAN and the dive business, and each relationship will require prior discussion before being offered.

The dive business staff members will not be covered by the Resort Membership programme. Each staff member will need to join as individual DAN member.

To join the DAN Resort Membership programme the minimum cost is \$500 per month. There will be a discount per additional dive centre associated with the dive business.

The cover will only be valid for dive-related emergency injuries and will exclude any evacuation unless, in the opinion of our diving medical officers, it is a life-threatening (critical) case and where the local chamber is unable to assist or is out of service. Evacuation is not to the client's place of choice, but to the nearest, appropriate medical facility which is able, at the sole discretion of the diving medical officer on call, to deal with the emergency. It also does not include repatriation to the country of residence.

The dive business agrees to the terms, limitations and conditions of the Resort Membership programme which is provided by DAN and, in the event of an accident, to provide a full accident report and any other documentation appropriate to this MoU.

The dive operation acknowledges that the DAN Resort Membership programme does not provide professional liability cover for the dive business, the resort, hotel and/or its personnel, and it hereby releases, forever discharges and agrees to indemnify DAN, its directors, trustees, officers and employees from and for any liability and suits of any kind, foreseen or unforeseen, resulting from the activities of the dive operation/s, the resort, hotel and/or its personnel.

This MoU shall commence on the date signed below and shall remain in force until termination upon either party giving to the other party no less than thirty (30) days written notice, or other period of notice as is agreed upon by both parties.

I/we hereby agree that this MoU shall require our adherence to all applicable international standards of training, safe practices and management of recreational diving operations, and including any national requirements that may apply in the regions where training and diving is taking place. The minimum fee is \$500 per month. Fees are based on the number of dive centres associated with a dive business per month.
