Thirty-sixth Annual Founder Region Conference Proceedings

The thirty-sixth annual Founder Region Conference was held May 4, 5 and 6, 2012 at the San Ramon Marriott Hotel, San Ramon, California.

Friday, May 4, 2012

Registration opened at 9:00 am on Friday, May 4, 2012.

The Trade Fair opened at 9:00 am.

She told stories about several women that we have helped live their dreams through the Women's Opportunity Award program. She also talked about how things are changing in Soroptimist, and introduced us to the new Live Your Dream website, an opportunity for new ways for people to support Soroptimist. The program will be officially introduced at the SIA Convention in Hawaii. Past President Sharon also talked about what is needed is strong clubs. We need to support The Women's Opportunity Award – this program has a huge impact on women and their dreams. She inspired us to support the new International Focus "Educate To Lead." She ended with an inspiring quote: "It takes an ocean of women, a tsunami of women to make dreams come true and change the world."

SIA Fundraising Report

Violet Richardson Awards

Program Council Dona then gave a history of the Violet Richardson Award, begun in 2000, named after Violet Richardson Ward, the first Soroptimist president in 1921. Violet was committed to creating opportunities for girls and young women through her affiliations with Soroptimist, the Girl Scout Council and the American Association of University Women. Her passion for community service, particularly as it affected women and girls, has been an inspiration to Soroptimist throughout the years. During the 2010-2011 club year, 54% of Soroptimist International of the

Americas clubs participated, recognizing 854 girls. For the 2011-2012 club year, Founder Region had 93% participation in the Violet Richardson Award. 58 award recipients and runners up receiving \$25,825 received and \$8,575 was donated to their respective charities. Dona thanked the members of the Violet Richardson Award committee: Chair Norene Lowry, District I – Gloria Bragg, District II – Judi Parent-Smith, District III – Kelly Barfield, District IV – Conni Wilson, District V – Hannah Winans, and District VI – Angie Haramoto. Dona asked the young women or their sponsoring club representative to come forward to share volunteer activities and receive recognition. Each winner or representative was presented with a certificate and a \$500 check from Founder Region by Governor Linda Sue, a check for \$250 to their organization of choice, and certificates from California Superintendent of Schools Tom Torlakson, and Congressman Jerry McNerney. The district winners were: Amelia Abramson, District I, sponsored by Soroptimist International of San Ramon Valley; Nicole Hohenstein, District II, sponsored by Soroptimist International of Diablo Vista; Becca Brookes, District III, sponsored by Soroptimist International of Clear Lake; Lizbeth Cabrera, District IV, sponsored by Soroptimist International of Sonoma Valley; Shoshana Lescht-Smith, District V, sponsored by Soroptimist International of Arcata and Sheena Chov. District VI. sponsored by Soroptimist International of Honolulu. The region winner whose name will be forwarded to Soroptimist International of the Americas was Lizbeth Cabrera. Lizbeth was awarded \$1,000 by Soroptimist International of the Americas with matching funds to her organization, Nuestra Voz.

Program Council Dona then gave a history of the Women's Opportunity Award which has been in

effect since 1972. During the 2010-2011 club year, \$1.5 million dollars in club, region, and federation funds were awarded to more than 1,221 women from 1,037 clubs in Soroptimist International of the Americas in 19 member countries and territories. The women receiving these financial awards may use them for any costs associated with their educational efforts, including tuition, books, child care, and transportation. There was 75% participation by Soroptimist International of the Americas clubs. For 2011-2012, Founder Region had 100% participation. For the 2010-2011 Women's Opportunity award impact report, Soroptimist International of the Americas sent surveys to 102 region level recipients from the 2007-2008 club year. The results of the survey are as follows: 97% of region award survey respondents reported an increased sense of self-esteem and self- confidence; 69% of region award survey respondents reported earning an educational degree/certification; 54% of region award survey respondents reported securing higher-paying employment: 80% of region award survey respondents reported an improved standard of living for themselves and their dependents; and 88% of region award survey respondents reported serving as a role model for their dependents. Dona thanked the members of the Women's Opportunity Award committee: Chair Dr. Christine Naber, District I – Barbara Lanier, District II – Jay-Marie Garcia, District III – Pam Herrera, District IV – Sandy Frazer, District V – Ada Kornmeyer, and District VI – Christine Ku Scott-Smith. She then asked the recipients to come forward to share their goals, life experiences and receive recognition. Each winner was presented with a certificate and two checks, one for \$1000 from Founder Region and one for \$3000 from Soroptimist International of the Americas, as well as certificates from California Superintendent of Schools Tom Torlakson, and Congressman Jerry McNerney. The district winners were: Felicia Wilson, District I, sponsored by Soroptimist International of El Cerrito; Anitra Eaton, District II, sponsored by Soroptimist International of 24/680; Angelique Longino, District III, sponsored by Soroptimist International of Vallejo Gateway; June Farmer, District IV, sponsored by Soroptimist International of Marin County; Nicole Macan, District V. sponsored by Soroptimist International of Eureka; and Georgette Leimomi Reynon,

received a laptop computer and a laptop case from Founder Region and an additional \$2,000 check from Soroptimist International of the Americas.

Alicia was unable to be present, however President Lillian Reyes told briefly about her work creating a task force on Human Trafficking. Governor Linda Sue presented President Lillian with a check for \$500 and a ruby shaped engraved paperweight, certificates from California Superintendent of Schools Tom Torkelson, and Congressman Jerry McNerney.

Operation Orphans International – Secondary School in Kenya

Governor Linda Sue introduced Tricia and Anthony Isayi, with Operation Orphans International who provided an update on their school in Kenya. She also announced that we have raised over \$15,000 from region members. Marge Dimmick, SI Eureka presented them with a check for \$1800 from funds raised by her church. Cindy Hardy from the Gold Refinery presented them with \$780 as a result of the Gold fundraiser at conference.
