The Forty-fourth Founder Region Conference – The Virtual Conference Proceedings

Due to the COVID-19 pandemic and the subsequent shelter in place orders, the 44th Founder Region Conference – The Virtual Conference evolved over a period of time spanning March 22, 2020 until May 2, 2020.

Sunday, March 22, 2020 – Caucus Conference Call

The Founder Region Caucus Conference Call was held March 22, 2020, at 7:00 PM PDT Via Conference call/Online Meeting.

Introduction – Governor Sylvia welcomed participants and explained that the call is being recorded and will be posted on the Founder Region website. "These are unprecedented times, and we are in unfathomable circumstances with being told to shelter in place with an invisible virus threatening our health. We are extremely saddened to have canceled our Founder Region Conference in-person event, and we hope you will stay tuned with our 44th Founder Region Conference as a virtual event. This will include voting for both our elections and Proposed Bylaws Amendments, our 2023 Conference Host Clubs, and our Founder Region Fellowship Previous Business Meeting Minutes. I am very glad you are on the call today. We have Laws & Resolutions Chair Sheila Bearden, Nominating Chair Amelia Benko, Fellowship President Pam, and I will be facilitating the call. Parliamentarian Barbara Lanier is also with us to provide guidance on any parliamentary questions that may come up."

Roll Call – Laws & Resolution Chair Sheila Bearden conducted the roll call by district with 95 members representing 31 clubs.

Invitation for Nominations from the Caucus floor – Governor Sylvia repeated the nominations and asked if there are any further nominations for each position. Lenore Colarusso from SI/24-680 has been nominated for Founder Region District I Director. The consent of the nominee has been obtained and the resume has subsequently been sent to all District I club Presidents by Secretary Pat Eileen Fisher. It is available on the Meetings/Conferences tab of the Founder Region website. Hearing no further nominations, the Chair declared the nominations for the 2020-2022 Founder Region Officers and District Directors closed.

Invitation for Nominations from the Caucus floor – Fellowship President Pam repeated the nominations and asked if there are any further nominations for each position. Hearing no further nominations, the Fellowship Chair declared the nominations closed.

President Pam took the opportunity to explain:

"An additional item that delegates will see on the ballot is for the approval of the Founder Region Fellowship Annual Business Meeting Minutes from the 2019 Conference. Secretary Jan Schults will be sending those via the District Directors and they will be posted on the Founder Region website for your review."

Instructions for Electronic Balloting Process – Governor Sylvia explained: The Founder Region Board met via conference call on March 15, 2020, and approved for Founder Region to do electronic balloting for the 2020 elections as suggested by SIA in light of

the cancellation of the May 2020 Conference due to the coronavirus. The following provisions apply:

- a. Registration form for Delegates due by April 8, 2020
 - i. 3 Delegates per club (President & 2 delegates)
 - ii. Delegates must have a personal email address
- b. Ballot invitations to be sent to email addresses of delegates
- c. Voting open April 15 May 2, 2020 closes at 12:30 PM PDT. (normal time of polls close during a conference)
- d. Applicable ballots are assigned to delegates based on the new district alignment

Governor Sylvia continued with explanations:

"The purpose of the Caucus is to allow time for clubs to learn about the proposed amendments and ask questions prior to voting, in this case electronically, on the proposed amendments. Because we will not have the in-person conference event, if there are any proposed amendments to the amendments for either the Founder Region proposed Bylaws Amendments or the Founder Region Fellowship proposed Bylaws Amendments, those may be presented on this call today and submitted in writing via email by March 29, 2020, to the appropriate leader – Governor Sylvia for Founder Region proposals and Fellowship President Pam for Fellowship proposals with a copy to Parliamentarian Barbara Lanier in either case. Confirming that any amendment to the proposed amendment is within the scope of the proposed amendment, we will then send out a special mailing to all registered delegates, and a special electronic ballot would be open from April 8 – April 14, 2020, to handle any amendment to the proposed amendment. A notification will be sent to all club Presidents explaining the opportunity to submit any amendment to the amendment proposals in writing by March 29, 2020, even if they are not brought forward on this call today."

She then turned it over to Chair Sheila to facilitate the Laws & Resolutions portion of the call.

Founder Region Bylaws Proposed Amendments - Laws & Resolution Chair Sheila Bearden read the Current and Proposed Language for each Bylaw Amendment. Discussion for each item was called by district.

Founder Region Proposed Bylaws Amendments 2019-2020

ARTICLE VI, Meetings Section 6.1 b

CURRENT LANGUAGE:

b. Every sixth year, conference shall be held at a site located within the boundaries of District VI.

PROPOSED LANGUAGE:

b. Every sixth year, conference shall be held at a site located within the offshore district.

Proposed by: The Founder Region Board of Directors.

Advantages: By changing the designation to "the offshore district", the reference will

apply to both our current and future district alignment.

Disadvantages: None **Financial Impact:** None

Rationale: The District Realignment which is effective on July 1, 2020, will change the

District numbers.

Maintaining the six-year cycle allows the election to continue to occur in the offshore

district on a regular basis.

Discussion of the term "offshore district" led to an amendment to the proposed amendment. After the Caucus Call and prior to the deadline of March 29, 2020, the following Amendment to the Proposed Bylaws Amendment on Article VI, Meetings; Section 6.1b was received in writing by Governor Sylvia:

Request to Amend the Proposed Amendment to Bylaws

SI Waikiki Foundation, Inc. requests to Amend the Proposed Amendment to Founder Region Bylaw, Article VI, Meetings, Section 6.1.b) by using the Proposed Language which follows:

"Every sixth year, conference shall be held at a site located within the boundaries of District V."

Proposed by: SI Waikiki Foundation, Inc.

Advantages: The election will continue to occur in the new District V every six years.

Disadvantages: None

Financial Impact: None

Rationale: The original Proposed Amendment used the language "offshore district" which is ambiguous and does not precisely describe the boundaries of the District. This change will ensure that the SI clubs in the U.S. Territory of Guam, the U.S. Commonwealth of the Northern Marianas Islands, the Republic of Palau, and the State of Hawaii are clearly within the definition.

The District Realignment which is effective on July 1, 2020, will change the District numbers. Maintaining the six year cycle allows the election to continue to occur in the new District V on a regular basis.

Founder Region Proposed Bylaws Amendments 2019-2020

ARTICLE IX, Finance, Section 9.2 Dues and Fees g

CURRENT LANGUAGE:

g. Each club shall pay Founder Region a fee of \$10.00 annually to support "S" Club or Sigma Society programs within the Region.

PROPOSED LANGUAGE:

g. Each club shall pay Founder Region a fee of \$10.00 annually to support "S" Club, Sigma Society or Dream It, Be It programs within the Region.

Proposed by: The Founder Region Board of Directors.

Advantages: Adding the Dream It, Be It program gives more opportunity to be able to award grants to Founder Region Soroptimist clubs to promote high school programs for girls.

Disadvantages: None

Financial Impact: Once accumulated funds from this account are reduced, stipulations on the number and amount of grants that can be awarded annually will need to be established.

Rationale: The annual dues assessment to all Founder Region clubs has accumulated over \$19,000.00. Currently, we receive approximately 1 to 2 grant applications per year for Start-up funds for "S" Clubs, and less than1 per year for "S" Club or Sigma Society projects. The Region board determined that the fund is underutilized and desires to expand the criteria for awarding grants for high school girls' programs. Many clubs do not sponsor "S" Clubs or Sigma Societies and could apply for a grant from this fund to start a Dream It, Be it program. The Dream It, Be It grant criteria will be added to the Founder Region Procedures.

After the Caucus Call and prior to the deadline of March 29, 2020, the following Amendment to the Proposed Bylaws Amendment on Article IX, Finance; Section 9.2. Dues and Fees was received in writing by Governor Sylvia:

Request to Amend the Proposed Amendment to Bylaws

Pam Parker, Founder Region Fellowship President and member of SI/St. Helena requests to Amend the Proposed Amendment to Founder Region Bylaws, Article IX, Finance, Section 9.2. Dues and Fees. g. which follows:

"Each club shall pay Founder Region a fee of \$10.00 annually to support "S" Club, Sigma Society or Dream It, Be It: *Career Support for Girls* programs within the Region.

Proposed by: Pam Parker, Founder Region Fellowship President and member of SI/St. Helena.

Advantages: Housekeeping matter to include full name of the Dream It, Be It: Career Support for Girls program.

Disadvantages: None **Financial Impact**: None

Rationale: The original Proposed Amendment used the language "Dream It, Be It" which is not the complete name of the program. The proposal is merely a change to show the entire name of the program throughout the original proposed amendment's Advantages and Rationale.

Fellowship Bylaws:

Fellowship Bylaws proposals reviewed by Laws and Resolutions Chair Sheila Bearden and Fellowship President Pam Parker are documented in the Fellowship Business Meeting Minutes at the conclusion of the Virtual Conference Proceedings.

Conclusion of Caucus Call: – Governor Sylvia thanked participants for their time and cooperation in reviewing the proposed Bylaws Amendments. We look forward to seeing all delegates participating in our electronic ballot in order to conduct our business in an efficient manner.

Monday, April 27, 2020

The 44th Annual Founder Region Conference – The Virtual Conference began during the week of April 27, 2020 through May 3, 2020. Special Virtual Conference and 2020 Conference Awards pages were created on the Founder Region website under the Meetings/Conferences tab. The Virtual Conference Program booklet was posted as a guide to following and accessing the events and presentations through updated links to recorded material from the three planned Live Zoom Events.

Wednesday, April 29, 2020

The Founder Region Legislative Advocacy presentation took place on Wednesday, April 29, 2020 during a 90 minute Live Zoom presentation beginning at 6:00 pm PDT. The theme: "Empowering Change to Eliminate Violence, Neglect, and Abuse Against Girls—Perspective on Effects of Violence and Trauma" was addressed by Deb Gee, a licensed Family & Marriage therapist. This presentation was recorded and a link posted on the Virtual Conference website page.

The Legislative Advocacy committee suggested clubs do a hands-on project focused on foster girls creating "Journey Bags" because oftentimes foster girls do not have toiletries and items of their own or anything to carry their items in when they are moved from home to home. A flyer was posted on the 2020 Virtual Conference page of our website with suggestions of items to include in the Journey Bags, as well as, a list of the types of social service organizations that might be contacted to be able to get them to the foster girls in your community.

Governor Sylvia reminded everyone participating on the Live Event that during this pandemic these journey bags could be just what is needed to show foster girls that we care. We would love for clubs to participate and Post a picture on Facebook and use the hashtag #Soroptimistsatwork.
