The Forty-sixth Annual Founder Region Conference Proceedings

The forty-sixth annual Founder Region Conference was held on April 29 - May 1, 2022, at the Waikiki Beach Marriott Resort & Spa in Honolulu, Hawaii.

Friday, April 29, 2022

Registration opened at 8:00 am. The Trade Fair opened at 8 am.

Governor Kris Chorbi opened the Legislative Advocacy session at 10:00am. She welcomed those in attendance to the Legislative Advocacy presentation "Poverty & Woman's Health". She asked that all electronic devices be silenced. Governor Kris announced the conference hashtag for sharing photos during the conference-#FR2022CONFERENCE.

Linda Witong, SI/Novato welcomed attendees via Zoom and thanked her committee:

Phyllis Gordon of SI/The Delta, Madalienne Peters of SI/Novato, Angie Haramoto of SI/Maui, Laura Middlemiss of SI/Humboldt Bay, and Sandra Simms of SI/Waikiki Foundation, Inc.

Committee member Angie Haramoto introduced the first speaker, Nikki-Ann Yee, Ma'i Movement Co-Founder, who appeared on Zoom.

The mission of Ma'i Movement is to provide and distribute free menstrual products to menstruators in need and advocate for systemic change in the government, schools, and community to end period poverty in Hawai'i. Currently they have an initiative proposed that takes steps to address menstrual inequity and end period poverty that requires low investment (\$5/student). Statewide statistics: a 2021 survey conducted by Hawai'i State Commission on the Status of Women and Ma'i Movement Hawai'i found that 42% of respondents reported missing class or leaving school early due to a lack of accessibility to period products. Furthermore, there is evidence in our islands that students are using period products beyond the recommended safe time, resorting to unhygienic alternatives and missing school because they cannot afford to purchase products in school or at home. The bill addresses this issue and promotes common goals of public health, basic equity, and gender equality and education equity.

Time was allowed for Q&A.

Committee Member Laura Middlemiss of SI/Humboldt Bay introduced a special video from DaysForGirls. Committee member Sandra Simms of SI/Waikiki Foundation, Inc. introduced Deborah Quigley from DaysForGirls.

Deborah Quigley is a child protection and human trafficking awareness activist and DaysForGirls Honolulu team leader. DaysForGirls works to increase access to menstrual care and education by developing global partnerships, cultivating Social Entrepreneurs, mobilizing volunteers, and innovating sustainable solutions that shatter stigma and limitations for women and girls. Through their education programs, they provide access to timely, factual information about puberty and menstruation and increased body literacy, a healthy public perception of menstruation and decreased stigma and shame.

Time was allowed for Q&A. Sandra thanked Deborah for her presentation.

Governor Kris thanked members for participating in the Conference Service Project to make period bags. She invited Barbara Lanier to the podium to tell us how SI/El Cerrito got involved in this project and what it means to the girls who receive these essential kits.

Governor Kris gave an update on last year's service project: Chair Cara Bagley and SI/Antioch coordinated the project and received dresses by the dozens. We far exceeded our goal of 100 dresses, and they stopped counting at 326 dresses being created. SI/Antioch and SI/Novato are continuing to make them so feel free to continue the project if you have the sewing bug. At least 100 of the dresses were sent to Tanzania by way of an SI/Antioch member whose daughter lives in Tanzania. Many countries in Africa, as well as the Philippines have received dresses. During the pandemic, when travel was heavily restricted, some dresses were given to foster girls in Contra Costa County.

Recessed at 12:00pm. Reconvened at 12:30pm.

Governor Kris welcomed members back from break and gave a cell phone reminder, and she announced the Table Drawing: On each of the tables there is an envelope with tickets inside. The tickets are \$2.00 each, three for \$5 or 7 for \$10. The lucky winner will receive a crisp, new \$50 bill from Treasurer Tess. Envelopes like these will be on the tables during each meal. The money we raise during lunch today will fund our Legislative Advocacy Programs.

Lisa Broulick, President of SI/Honolulu, provided the Inspiration Barbara Yamashita, President of SI/Waikiki Foundation, Inc. provided the Welcome.

Governor Kris called upon Chair Linda Witong to introduce Leigh Elwood-Brown via video on how our advocacy work throughout Soroptimist International is helping women overcome the obstacles to their health and wellness.

Governor Kris then asked the Official Visitor, SIA President-elect Stephanie Smith to share how the Soroptimist Dream Programs can empower women to make their health a priority for living their best life. President-elect Stephanie spoke on why the Dream Programs are so important and how they can impact women and girls throughout their life.

Governor Kris thanked the Legislative Advocacy Committee and speakers who worked tirelessly to make our program memorable with the presentation on "Women's Health". Governor Kris presented Deborah, Sandra, Angie, and Laura with a token of gratitude.

Governor Kris asked Conference Coordinator Lyn if there were any announcements – there were none, so we adjourned for a break until 2:00pm

The Table Drawing winner was announced and given \$50. A total of \$601.00 was raised for Legislative Advocacy Programs.

She presented President-elect Stephanie with a small gift as a token of her gratitude for her participation in our Legislative Advocacy Program.

Delegates were advised to stay for the Delegates Briefing beginning at 2:30pm and Pages and Timekeepers are to return at 2:45 pm for their briefing.

All Fellows were invited to attend a Fellowship Reception at 5:30pm to meet the Fellowship recipients. The No-Host cocktail reception for all members on the Kona Moku Ballroom Lanai will begin at 6:00pm, with the Fellowship Awards Gala & Dinner to begin at 7:00pm. Tomorrow's Fellowship Meeting starts promptly at 8:00am following by the Region Business Meeting.

Quorum for Opening Session 48

Governor Kris repeated the credential report and asked if there were any questions. Governor Kris called for the vote and Founder Region Credentials Report #1 was adopted by the delegates.

Governor Kris called upon Secretary Joy to read the Conference Standing Rules. Secretary Joy said the Standing Rules are printed in our 2022 Founder Region Official Conference Program and are found on page 33. In the interest of time and with no objections, the Standing Rules were not read. She moved for the adoption of the Standing Rules. The standing riles were adopted by a two-thirds vote.

Governor Kris called upon Secretary Joy to read corrections to the conference program. Secretary Joy moved for the adoption of the Official Program. The Official Program was adopted by a majority vote.

Governor Kris announced that there are 36 first time attendees registered and asked them to rise and be recognized.

Governor Kris asked for the pages to rise. They are responsible for microphones, messages to the chair, door-keeping, and Patti Laba and Julie Takushi will assist you at the microphones; Kim Jones and Lisa Ma are the timekeepers. Governor Kris thanked the stewards: Cindy Rasmussen of SI/Waikiki Foundation, Inc will be supporting Governor Kris and Governor-elect Vicki; and Susan Lau of SI/Central Oahu will be supporting Fellowship President Cheryl and our Official Visitor Stephanie. Host clubs committee members were recognized.

Members were informed to look for special greetings from Michelle Burnett, SIA CEO and Executive Director and our official visitor, SIA President-elect Stephanie Smith in the Conference Program.

A Video was shown from SIA President Kazuko Morita.

Governor Kris called upon Secretary Joy to read the greetings and correspondence. Secretary Joy read a letter from Past Governor Bobbi.

Secretary Joy announced the clubs volunteering to host the Founder Region Conference in 2025: SI/The Delta, SI/Vacaville, and SI/Vacaville Twilight. She moved the acceptance of these clubs to host the 2025 Founder Region Conference, which requires a majority vote. Governor Kris called for a vote. Motion passed.

Treasurer. The chair declared Danelle Tegarden the Fellowship Treasurer. Governor-elect Vicki called for a vote to elect Kris Chorbi as the Fellowship President. Kris Chorbi was declared the Fellowship President.

As there is more than one candidate for the Fellowship Director, District I position, delegates for District I will vote by ballot during our lunch break.

FOUNDER REGION ELECTION

According to Article V, Section 5.2 Elections (a) of the region bylaws, "Voting shall be by ballot unless there is only one candidate for office; in such event voting shall be by voice vote." We continue to vote for those candidates who are running UNOPPOSED for the Founder Region Board by voice.

All club delegates and region board members may vote for the district director candidate of their respective districts. Governor Kris announced the Founder Region Board District I nominee and called for the vote. She declared Lenore Colarusso as District I Director. Governor Kris announced the Founder Region Board District II nominee and called for the vote. She declared Jackie De Vries as District II Director. Governor Kris announced the Founder Region Board District III nominee and called for the vote. She declared Colleen Ganaye as District III Director. Governor Kris announced the Founder Region Board District IV nominee and called for the vote. She declared Elaine Reed as District IV Director. Governor Kris announced the Founder Region Board District V nominee and called for the vote. She declared Teri Lynn Sato as District V Director.

Governor Kris announced that all club delegates and region board members may vote for Region Secretary, Region Treasurer and Governor-elect. After the vote she declared Tess Albin-Smith as the Region Treasurer. The vote was held for Region Secretary. She declared Kristal Koga as the Region Secretary.

As there is more than one candidate for the Governor-elect position, delegates voted by ballot during our lunch break. Nominations chair, Amelia thanked her committee: Bonnie Mertz, Jan Shultz, Barbara Young, Dyann O'Brien, and Angie Haramoto.

OFFICIAL VISITOR PRESENTATION

SIA President-elect Stephanie Smith was introduced by Governor Kris. Stephanie is a motivational speaker/trainer by trade. Her Official Visitor presentation was entitled, "Dream BIG, the Power of Women to Change the World", and we are counting on her, as SIA President-elect to lead the charge and lead the members of our federation to "Change the World" as well.

Governor Kris asked Chair Stacey if there were any changes to the Credential Report - there were no changes. In preparation of presentation of the Proposed Amendment to Bylaws, we will review the discussion process: timekeepers for this session were Kim Jones and Lisa Ma; Patti Laba and Julie Takushi will assist members at the microphones.

Governor Kris reviewed the procedures:

Discussion time for each proposed amendment is ten minutes. If a delegate wishes for the discussion time to be extended beyond the ten minutes as provided in the standing rules, such delegate would need to make a proper motion to extend the time within the initial ten-minute period. Delegates can speak FOR or AGAINST an issue for a maximum of TWO MINUTES. Any member can speak to an amendment but only Founder Region Delegates can make a motion or other point of order. Delegates have priority at the microphone verses a non-delegate member. The timekeepers would hold up colored cards to indicate the amount of time remaining. The GREEN CARD would go up when you have one minute remaining. The WHITE CARD would go up when you have thirty seconds remaining. The RED CARD would be raised when your two minutes has expired, and the delegate must STOP. When the ten minutes have been exhausted the timekeeper will so indicate, with the RED STOP card and the sound of a bell. There were signs at each microphone that assisted the chair in recognizing a speaker. The signs say: FOR, AGAINST, INFORMATION AND AMENDMENT. When a speaker addresses the chair and delegates, they are to state their name and the club to which they belong. There are blank motion forms on each table for any motions or amendments. Please write out the motion or amendment and give it to a page who will deliver it to the chair.

Governor Kris introduced Laws and Resolutions Chair Sheila Beardon to read the proposed amendments, which were projected on the screen. There were no objections to the chair not repeating the entire proposal.

Prior to voting on this amendment Parliamentarian Barbara clarified why there are two amendments on Article IX, Finance Section 9.2 Dues & Fees c. The amendment proposed by Founder Region Fellowship clarifies the fee that will be paid as fellowship dues. The amendment proposed by Founder Region adds the corrected amount and specifies who the dues will be paid to. Article IV, Officers Section 4.5 duties d passage will affect this article.

Governor Kris asked if there was any discussion then asked if delegates were ready for the question. This requires a two-thirds vote. Delegates raised their voting card in favor. The delegates opposed raised their voting cards.

Motion passed.

A motion was made to this amendment by Governor-elect Vicki to strike the word "invoicing" and inserting it its place the word "collection". Change from "Founder Region Fellowship shall be responsible for invoicing of Fellowship dues, assessments and donations" and change to: "Founder Region Fellowship shall be responsible for collection of Fellowship dues assessments and donations", as dues are not invoiced. Motion was seconded. ARTICLE X, Founder Region Fellowship, Inc Section 10.2 strikes the word "invoicing" and inserts in its place the word "collection".

After discussion a vote was called for the amendment to the main motion.

Motion passed.

Chair Sheila read the main motion, as amended.

Governor Kris asked for any discussion on the proposed main motion, as amended, then asked if delegates were ready for the question. This requires a two-thirds vote. Delegates raised their voting card in favor. The delegates opposed raised their voting cards.

Motion passed.

Governor Kris thanked Chair Sheila and Parliamentarian Barbara for doing such as great job and presented them with a gift for their dedication to Founder Region.

Treasurer Tess Albin-Smith gave the treasurer's report. She welcomed attendees and reported on the two region financial reports and a proposed budget included in their welcome bag. Balance Report: Bank balances as of the end of March include investments, savings and checking accounts. Budget vs. Actual Report: The 2-year biennium 2020-2022 Budget vs. Actual Report reflects how much we spent vs budgeted in each category. This report is from July 1, 2020, through March 3, 2022. Many expenses have not occurred yet, such as award checks we are giving out and income not yet receive such as money from Conference fundraising. This will change actual parts of the report for the next two months. Governor-elect Vicki's 2022-2024 Proposed Budget was also distributed. Treasurer Tess indicated if there are any questions, she would be happy to discuss at the breaks.

Governor Kris thanked Treasurer Tess for her report and reminded delegates to vote prior to lunch. There are no updates to the credential report previously given. The credentials report previously adopted remains in place. The following member are tellers for the election by ballot today: Bonnie Mertz, Barbara Young, and Angie Haramoto.

Elections Chair Amelia explained the procedures for voting on District I Fellowship Director and for Governor-elect. Voting will take place in Milo 4/5 room, located outside the ballroom down one flight of stairs on the second floor, until 12:30pm.

All club delegates and region board members may vote for Governor-elect. All District I club delegates, region board members from District I and Fellowship board members from District I may vote for the Fellowship director of District I. Delegates were advised to proceed to the voting rooms and make sure that they have their name badge visible and their credential cards with them. Two people will be at the entrance door to verify your name tag and credential card. They will direct you to your district to receive your ballot.

Governor Kris asked Conference Coordinator Lyn if there were any announcements - there were none. She announced the recess until 12:30pm when we reconvened to enjoy the District Directors "Dream BIG" Luncheon. Presidents were instructed to meet their District Director in the lobby before lunch for the Presidents' Processional.

God has been very good to me in my life and I felt the need to share what I could of my time, talents and treasures with others in need. And who better to help than the women and girls facing obstacles in their lives? That is what Soroptimists do! We can all Bee anything! We can Bee Kind, Bee Helpful, Bee Courageous, you can fill in the blank with just about any positive word. And in the upcoming biennium we can all "Bee the Dream!".

And to Past Governor Amelia, thank you for honoring me as my installing officer. You have always been supportive of me through my years as a Soroptimist and I am grateful. Thank you all for being here as we prepare for the 2022-2024 biennium and remember to always "Bee the Dream!".

Governor Kris addressed the audience with her Outgoing Governor's Speech.

She spoke on the challenges of the past two years with a virtual conference, Zoom meetings, the Founder Region Tutorials on topics like Zoom, Facebook, and Websites, which led to trainings on Dream It, Be It, Club Treasurer, Live Your Dream and Dream Big topics. The District meetings were held virtually. The Region Conference went virtual for a second year in a row and we held events over 5 days and nights with over 1,000 in attendance. We had speakers from across the globe and throughout the state of California talking about Pay Equity, the Road to Equality, and the history of Soroptimist. We celebrated our centennial with Women in History trivia games, presentations on Pop Culture through the decades, and a fun re-enactment of the first meeting of Soroptimist. A Conference service project continued virtually as we took to our sewing machines to make dresses for girls on the other side of the world. Fun was had in solitude, in our own homes, in front of our computers, but together in spirit making the best of the situation, we were dealt.

This was the biennium of the ever-changing plans. Planning for live events, then pivoting to virtual, then to hybrid, and finally to the first in-person conference in 3 years. There was no roadmap for this type of biennium. We made it up as we went along, but SIA was on top of the changing times as well. They released countless recourses in their Virtual Toolkit on fundraising, membership, program and public awareness to help clubs and regions navigate this new normal. She went on to share more thoughts on the past biennium including what our Live Your Dream winners had to endure during these difficult times.

Governor Kris went on to thank all the members of her board for their contributions to making this a successful biennium. She thanked Fellowship President Cheryl, the Fellowship board, Parliamentarian Barbara, and all Region Committee chairs. She stated: "It was my honor to preside as your Governor over the past two years. Thank you for your support and for the love you have bestowed upon me. I tried my best to lead the region through this unprecedented time in history and I hope my legacy to "Dream BIG for the future!" will guide the members of Founder Region for many years to come."

As a member of the Hoopa Valley Tribe and descendant of the Yurok and Chimariko Tribes, Lindsay resides on the rural Hoopa Valley Indian Reservation. It is there that she founded Native American Pathways (NAP), a non-profit dedicated to providing social and wellness support through relationship building, youth mentorship, and community outreach services to Indigenous communities. Her true dream is to receive her degree in psychology to better assist her community members in achieving wellness.

Governor-elect Vicki introduced Chair Debbie, who announced the Live Your Dream Recipients for 2022. Those in attendance were invited to speak and were presented with a certificate and check.

Four of our district Live Your Dream Award winners have received \$2,000 from Founder Region and \$3,000 from Soroptimist International of the Americas for a total of \$5,000. However, one of our district winners is also our Region winner and she has received \$5,000 from Soroptimist International of the Americas, and a \$2000 check and a \$500 gift certificate to Amazon from Founder Region, for a total award of \$7,500.

The Live Your Dream Recipients were instructed to open their envelopes. The winner who will be advancing to Federation level was "Joan" from District I sponsored by SI/Oakland-The Founder Club.

Governor-elect Vicki introduced Sandra Simms, SI/Waikiki Foundation, Inc., who announced the keynote Speaker, Suzanne Puanani Vares-Lum, President of the East-West Center. She is the first woman, Native Hawaiian, and Hawai'i resident to be chosen for this role. Vares-Lum brings executive leadership and planning experience spanning the past several decades, culminating in five years serving with and advising the most senior officials at US Indo-Pacific Command, where she cultivated and maintained key relationships with nations throughout the Indo-Pacific region. As a retired Major General with 34 years of service in the U.S Army, Vares-Lum has held key roles addressing priority national security challenges in the region.

Governor Kris thanked Suzanne. She also thanked Governor-elect Vicki for the wonderful Awards Program. Governor

Kris asked Live Your Dream Chair Debbie to come to the podium. She thanked her for the wonderful job she did this year and announced that she had agreed to be the chair for the next biennium.

DREAM IT, BE IT REPORT

Governor Kris invited Chair Bev Gomer to the podium to talk about Dream It, Be It – Career Support for Girls Program. The global impact in fiscal year 2020-2021 was 10,178 girls across 14 countries and territories who participated in the Dream It, Be It: Career Support for Girls program. Despite the pandemic, Soroptimists reached many girls. Clubs also get SIA credit for participation when they support another club's project, which need only complete one of the seven sessions from the Dream It, Be It curriculum to get SIA credit! A Club Planning Toolkit, Curriculum Overview, Guidelines for Working with Youth and Tips for Successful Projects, as well as Tips for Facilitating Groups, are available. Clubs can apply for a Soroptimist Club Grant from SIA to support their projects, or apply for a \$500 grant from Founder Region, but not both. Founder Region requires that at least three of the seven sessions in the curriculum be completed.

Governor Kris thanked Chair Bev for her work supporting this program and presented her with a token gift of her appreciation.

The last Table Drawing was held with a member receiving \$50.00. A total of \$665.00 was raised for the Region Dream Programs.
