Recommendations for Day of Event: Please come with clean, dry hair for event styling. If you require a blowout prior to your styling service, an additional \$30.00 is added. A button-down shirt or robe would be best to preserve your beautifully styled event hair and make-up.

MAKE UP ARTIST: I can recommend or bring in a make-up artist for your event. This contract is specifically for hair. If you are interested, I will have the artist provide you with their fee and contact information.

MINIMUM: The minimum on-location fee is \$250.00. For out of town weddings, a hotel room must be provided at the site of the event. If flight is needed, you must pay for all flight expenses.

TRAVEL FEE: There is a \$50.00 travel fee per stylist within a 25 mile radius of Charleston, SC. Surrounding areas outside of 25 mile radius will be determined based on location.

CONTRACTED SERVICES PER PERSON: You may add any people up to the wedding date, if time allows for the hair and make-up artists. You may subtract people up to 2 weeks prior to the wedding date.

DEPOSIT & PAYMENT: A \$100 non-refundable deposit and signed contract is required to reserve and hold your wedding date. Deposits and contract may be mailed, or deposit paid through credit card. A credit card will need to be on file 3 weeks prior to the event date. The initial deposit will be applied to your day-of services. Payment in full is expected day of services provided. *Cash and all credit cards are accepted. Gratuity is appreciated.*

CONTRACTED DATE: You may cancel this contract anytime up to 2 weeks prior to your wedding date of service and only lose deposit. After that you will be charged 50% of the quoted rate. If you cancel within 48 hours prior to service date, you will be charged 100% of the quoted rate. This contract is non-negotiable.
